Course Description

This course is an examination of punishment and treatment objectives as they describe the functioning of institutional entities such as jails and prisons; while connecting these institutions to the operations of community corrections (including probation and parole systems). A connected investigation of the complete correctional system including from maximum punishment to minimum community type institutions. Prerequisites: CRIJ 1301; CRIJ 1306 and/or CRIJ 1310 and earning at minimum a C in each of these courses.

Student Learning Outcomes

- > Understand the variety of ways society punishes people who break criminal laws
- Identify the theoretical underpinnings of correctional systems and understand how correctional practices are shaped by these theories
- Explain the benefits, drawbacks and competing considerations involved in different correctional methods
- Think critically about our correctional practices and develop informed ideas about how our justice system should respond to people who break the law

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Using the learning management system (D2L/Brightspace), using Microsoft Word and PowerPoint, using presentation and graphics programs, and Turnitin. Written and oral communication skills; reading; memorization; critical thinking. You should know how to access a Web site when given an address, use the features of your Web browser, download files, attach files to emails, and use word processing software, ...etc.

Instructional Methods

This course is designed in a format that is delivered asynchronously 100% online. In the online environment, students will be engaged in discussion forums and weekly unit completion of materials that will lend success to completion of the course work. The weekly lessons will be released by Sunday at 5pm.

Each week/unit starts on Monday and ends on Saturday at 11:59pm CST and your grade for activities will be posted as soon thereafter as possible.

This course will provide a variety of activities and assessments to assist you in achieving the outcomes/objectives for the course. You will work toward achieving these outcomes through discussions/comments, written assignments, video assignments, quizzes and exams.

Student Responsibilities or Tips for Success in the Course

The student must log into the course through myLeo multiple times throughout the week to complete weekly assignments and post and respond on discussion boards. Weekly reading is expected as well as taking scheduled quizzes/exams and completing all other assignments. Students should check email daily and set up automatic notifications for announcements and other reminders in the D2L system. Any changes/updates to assignments will be posted mainly through the "Announcements" tool on D2L.

Students must cite in-text using APA style for all assignments. Late written assignments receive a 20% deduction in points and cannot be accepted beyond one week of the due date. Late comments on discussions will not be accepted. Quizzes cannot be made up. Exams will only be allowed a late submission under extenuating, documented circumstances. Written assignments and discussions cannot be regraded

or redone. All written work is subject to Turnitin review. Any student who plagiarizes will receive a zero on the assignment in question.

Students, it is advisable that you meet with our professionals in the <u>Writing Center</u> in order to learn how to construct your research paper. The Writing Center has a number of classes students can attend and I strongly advise you to attend some of them so that you can learn how to construct a professional research paper which will more than likely improve the grade.

Should you decide to use the Writing Center for assistance with your assignment, I will grant you a ten (10) point bonus, which will be added to your assignment. Proof from the Writing Center that you received assistance on your assignment is required to receive the ten (10) point bonus.

Quizzes: (10 quizzes at 10 points each = 100 points)

There will be 10 quizzes in this course to ensure that you are reading the assignment materials and keeping up with course requirements. The quiz must be completed by 11:59 pm on Saturday on each week a quiz is assigned. The quiz will mainly focus on

the assigned readings. The quiz will be released on Sunday and you may take it at any point in time during the week. You may take the quiz up to 2 times. Your highest submitted score will be recorded. You will have a time limit of 7 minutes. Scores will be released on the following Monday after the Saturday deadline. There will be no make-up quizzes allowed.

Exams: (2 exams at 150 each = 300 points)

Exam #1 (Midterm) is due by October 16, 2021 at 11:59pm CST.

Exam #2 (Final) is **during Finals Week and is <mark>due by December 15, 2021</mark> at 11:59pm CST.**

<u>Assessment Method</u>: Multiple choice/true false and/or short answer/essay questions.

Participation/Discussions: (10 posts/comments at 40 points each = 400 points)

There will be 10 discussions posted throughout the semester worth 40 points each total (30 points for the initial post and 10 points for your comments). Discussion on topics must be done during the week(s) we are discussing the course material. Posts are due on Thursday by 11:59pm and comments are due by Saturday at 11:59pm of the week assigned.

Introduction (1 Introduction post not graded) Every student must introduce him- or herself by the fifth day of class (Friday) during Week One. This information will be entered as a threaded discussion. You will receive 10 extra credit points for completing this task by the deadline.

Each student's presentation should cover the following information:

- Name
- Occupation/career and length of time
- How this course is expected to help or aid your career, separate from the entire degree
- Describe how you expect this degree to enhance your career
- Also include a statement that you have read the syllabus and agree to abide by <u>Netiquette</u> terms.

Discussion Posts

The Discussions in this class will focus on the specific assignments connected to each week. Each student is expected to participate in the weekly discussion by responding to ideas(s) presented by the professor. A minimum of one initial discussion per week is required by Thursday at 11:59pm of the week assigned and two peer responses by Saturday. This must not be all on one day. Students may post earlier than the absolute due date if desired, but no later than the identified date. Posts are due by Thursday at 11:59pm of the week assigned. Five (5) points will be deducted for posts made after the Thursday deadline. The post will close on Saturday of the week assigned.

The **Discussions** are directly related to the assigned lecture material. Upon completion of the assigned lecture material, you are expected to engage in an **ongoing** discussion/debate with your classmates. Your contributions to the discussion forums will be graded for **quality** and a **detailed analysis** linking the material to a critical appraisal

of theory, policy, and practice. You must integrate course material (textbook) and outside material into your post and cite it properly. In all cases, students must have at least one in-text citation and provide a full reference citation at the end of their post for all citations mentioned in the post in APA format (See information later in the syllabus for more information on citing utilizing APA citation format).

These posts should be **the equivalent of 1 page minimum in length or a minimum of 250 words**. The specific discussion assignment is located in each unit Week by clicking on the Discussion link.

Posts are due by Thursday at 11:59PM CST during the week assigned.

Comment Posts

Comment posts are responses you make to the discussion posts that you and your classmates post each week and are due by Saturday by 11:59pm. You are **required** to make a minimum of **two** comments for each discussion. I would strongly encourage you to engage your colleagues well past the two-comment minimum in order to maximize your opportunity for meaningful discussion and learning.

Comment posts should be meaningful. Merely agreeing or disagreeing with a classmate will not be looked upon favorably and will result in a loss of points. A meaningful post is one that moves the discussion forward in some substantive way through providing one's perspective, additional information through research, or reframing the discussion in some new way. You are expected to engage in an **ongoing** discussion/debate with your classmates. Your comments will be graded for **quality**, and **relevance**. Your comments will also be graded based on your ability to engage in critical thinking. Students **must** provide **one outside source** for **at least** one comment that they make **cited in APA**. Integration of outside examples, statistics, and relevant facts are necessary to show an understanding of the subject matter.

NO LATE COMMENTS ARE ACCEPTED. All comment posts are due by Saturday at 11:59PM of the week assigned.

Assessment Method: Comments and the Discussion Post will be graded using the Discussion/Comments Grading Rubric (Appendix A). The discussion and comments for each week will be graded together and posted as one grade (Discussion = (30) + Comments 2@ 5 points each (10) = 40 points).

APA Citation Format Policy

It is very important that you learn how to cite properly. In some ways, citations are more important than the actual text of your paper/assignment. Therefore, you should take this task seriously and devote some time to understanding how to cite properly. If you take the time to understand this process up front, it will save you a significant amount of time in the long run (not to mention significant deductions in points).

In the social and behavioral sciences (including Criminal Justice), we use APA (American Psychological Association) format. As a rule of thumb, one cites whenever they are paraphrasing other people's words or when they quote other's words directly. You may learn to cite from a variety of different sources including the APA Tutorial and the sources listed below. The campus library and writing center have many helpful resources as well – <u>TAMUC Writing Center</u>.

Evidence Based Practice Writing Assignment

200 points total - 25 for topic (see below) and 175 for paper (see grading rubric)
 Important Dates: Topic Selection Due - 10/16/21
 Paper Due - 11/29/21
 **Late topic submissions/papers may be turned in up to one week past the due date but will receive a 20% deduction in points. Papers will not be accepted after 12/6/21.

Topic Selection Options:

Privatization of prisons Geriatric (Elderly) Inmates Healthcare Issues for Women in Prison Mother and Child Programs in prisons LGBTQ Inmates Juvenile Secure Institutions Technology use in prisons Contraband control in prisons or jails Life Sentences Management practices for prisons

Restorative Justice/Shaming as a correctional alternative Treatment/punishment for DWI offenders Treatment/punishment for sex offenders Diversion programs

Technology use in community corrections Veterans Courts Mental Health Courts Intensive Probation Supervision Community Corrections Facilities (short term community based) Management practices for community corrections departments (probation or parole) Juvenile Detention alternatives

Students can select only one topic from the above suggested topics and that topic must be approved prior to the student beginning work on his or her research paper. Only 3 students will be able to select the same topic – so get your selection in early. I will post an announcement once a topic has reached capacity.

It is up to the student to focus the topic and create a thesis statement from the broader topic selection options.

A detailed topic description and annotated bibliography, including a thesis statement and at least three identified sources will be submitted by 10/16/21 to be approved by the instructor (25 points). Topic description should be at least one paragraph in length and sources should be listed in APA format with a brief

description of the main subject matter to be incorporated from the source into the research paper.

This is an academic research paper that requires you to discuss the importance of the selected topic in the context of the correctional umbrella. In addition, this assignment calls for you to provide a discussion of evidence-based practices in regard to the topic you have chosen. What does research lead us to believe and what is the current "best practice" in regard to the topic? You should incorporate current examples from specific correctional jurisdictions on how these "best practices" have been integrated and an assessment of how this topic should be approached in the future. What changes need to be made in the correctional approach based on your research?

Writing Assignment requirements:

All written assignments must be presented in a computer-generated form via Turnitin in myLeo, adhering to APA format/guidelines. Student's paper must be twelve (12) point Times New Roman font, including page numbers, doubled spaced and one (1) inch margins are REQUIRED.

Your paper must be at least a minimum of five (5) pages to a maximum of eight (8) pages, which **does not** include the Reference page or title page using APA format. An abstract is not required. Students are to include a "References" page as the final page of your paper, which lists your reference sources in APA. Also, make sure you cite your sources in APA format within the contents of your document. See "APA Citation Format Policy" in syllabus.

It is the student's responsibility to have a minimum of a total of eight (8) or more professional resources; two (2) of these sources must be **peer reviewed** journal articles. The additional sources can be academic books, trade journal articles, and other academic publications (.gov and .edu). Do NOT use Wikipedia, newspapers, or magazines as core reference sources. Your written assignment must be your own original work for this specific class.

All papers will be submitted through Turnitin in myLeo, NO EXCEPTIONS.

NOTE: Assignments receiving a similarity rating greater than 45% in "Turnitin" WILL NOT be accepted. Students submitting assignments with similarity ratings greater than 45% will get one opportunity to revise and resubmit the written assignment as long as it is before the due date.
