Course Description

The definition of a playwright is someone who *builds* plays, rather than simply writing them. To do this a writer must have an immense understanding of character, conflict, and consequence. Every playwright has their own unique voice and style, often derived from their own life experiences. This course is designed to help each student become a builder of plays, and to allow that unique voice and perspective be discovered and shared.

Student Learning Outcomes

- 1. The student will be able to understand the basic tenets of playwriting within the parameters of a dramatic work.
- 2. The student will be able to identify a variety of playwrights, writing styles, and writing techniques.
- 3. The student will be able to participate as a professional in workshops with both their own and other students' works.
- 4. The student will be able to complete a production ready draft of a short play.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students must have access to a computer and the ability to use Microsoft Word or other

word-processing software. Students must also be familiar with how to use the D2L Brightspace platform including uploading documents to Dropbox as .pdfs.

Instructional Methods

Students will be graded on a series of reading selections, class projects, practical application of the knowledge that they have learned, the completion of a draft of dramatic work, as well as in class discussion and exams.

Student Responsibilities or Tips for Success in the Course

- 1. Be on time.
- 2. Be prepared. Read what needs to be read. Write what needs to be written.
- 3. Participate. There is a great deal of exciting discussion in this course, and it will be even more exciting with your ideas.

Assessments

Short Writing Assignments: Through the first half of the semester at least once a week I will assign a short writing assignment based on a prompt given in class. Often you will have class time to begin writing. They will be due, typed and formatted correctly, on D2L each Sunday night by midnight.

Discussion/Participation: This is not simply about showing up but about being involved in the class discussion and participating as a respectful collaborator. The largest part of this grade will be related to your participation during in class readings/workshops of both your and your classmates plays. Guidelines for the workshops will be provided in class.

Midterm Exam: This exam will be over the information covered early in the semester both in readings from the texts and class lecture/discussion as well short play readings provided by the instructor.

Playwright Presentation: Each student will choose or be assigned a working professional playwright to interview (in person, via e-mail, or video conferencing) about their writing process. The student will write a 700 word essay on what they learned from the playwright and create a short presentation for the class. Further instructions will be given in class.

Production Ready Draft. After the midterm exam, each student will choose from their short writing assignments the beginnings a ten-minute play. The second half of the semester will be spent developing that play through writing in and out of class as well as in class readings/workshops. The final assignment for this course, due on the last day of class, will be a production-ready draft of the play. Further instructions will be given in class.
