#### **Course Description**

This course will provide an overview of the major problems facing global society and provide a historical context to the development of those social problems. Students will learn how global social problems are complex and require nuanced thought to reach solutions. Students requirements will focus on critically analyzing stratification, inequalities and social problems on a global scale. Students will learn cross cultural competency by examining problems in a variety of global settings outside of the U.S.

#### **Student Learning Objectives**

1. Students will be able to identify various forms of global social inequalities. This SLO will be assessed in exams and weekly discussions.

- 2. Students will be able to define various forms of social privilege on a global scale. This SLO will be assessed in exams and weekly discussions.
- 3. Students will be able to critically evaluate how global social issues are constructed outside of the U.S. This SLO will be assessed in media analysis paper.

# **COURSE REQUIREMENTS**

This course will be delivered entirely online. You must have access to D2L in order to complete the requirements for this course.

#### **ASSESSMENTS**

## Weekly D2L Discussion Posts: (10 posts @ 20 pts: 200 points total)

Each week students will need to post a 500 word summary of the week's readings and how the readings help to understand a video that pertains to the topic for the week. Students must interact with at least two of your fellow students' post each week.

# Exams: 4 Exams (@150 points each, 600 Total)

The exams will be non-cumulative and only cover reach week's reading materials from the assigned chapters. Exams will be 50 questions long, and you will have a time limit of 60 minutes. Exams will include multiple choice questions. All exams will be taken on D2L

#### Short Media Analysis (1@ 200 points, 200 Total)

You will choose a piece of media (news article, television show, movie, music video, song) to analyze in terms of how global social issues are presented within the U.S. media. You will write a one to two page double spaced paper that clearly cites ideas, theories and themes from the textbook and readings. Please do not over summarize the piece of media...just point to how the media portrays global social problems within the U.S. Provide an argument that asserts your link between inequality and your media example and carry that argument through a clear four to five paragraph essay.
