COURSE DESCRIPTION

This course focuses on introducing and developing the basic acting techniques of characterization, role analysis, stage movement, voice, and body control.

Course Ethics and Attendance:

Note that attendance alone does not constitute participation. Promptness, attendance, and "attentiveness" are valued in this class. Please behave accordingly and do not disrupt the class with excessive talk or the use of cell phones or other devices. This is a class that will be challenging, invigorating, and participatory. Active participation in discussion and presentation of projects within the class is not only welcome, but also an essential requirement. Positive, helpful and constructive attitudes are also required!

Presentations must be well prepared and shared with the understanding that questions and discussion will follow. The ongoing critique of performance is crucial to everyone's learning process. You should be aware that the vast majority of class time is composed of activities in which you are REQUIRED to actively participate. You will be up on your feet and moving almost every single day. *If you have no plans or interest in sincerely exploring the artistic process of acting and accomplishing significant growth as a performer, this is not the class for you.*

Student Learning Outcomes: By the end of this course, the student will be able to:

- 1. demonstrate understanding and practical proficiency in executing the
- 2. foundational principles of Stanislavski's approach to realistic acting for the stage.
- 3. display acquisition of effective skills in working with others via a disciplined, collaborative, professional, respectful, and productive approach throughout the rehearsal and performance processes.
- 4. exhibit proficiency in accepting and incorporating constructive criticism into his/her own performances, while developing the skills needed to humanely and insightfully evaluate both personal artistic efforts and the work of others.
- 5. gain confidence speaking, teaching and working in front of peers, by mastering appropriate warmup techniques, vocal exercises and practicing varied performance styles.

COURSE REQUIREMENTS

Classroom Participation- 200 points total: *Note that attendance alone does not constitute participation.* Promptness, attendance, and "attentiveness" are valued in this class. Please behave accordingly and do not disrupt the class with excessive talk or the use of cell phones or other devices. This is an acting class, so participation is required. We will be moving in this class, so please make sure to wear clothing that allows for movement.

Character Paperwork- 150 points total (6 assignments at 25 points each): For each performance the students will fill out paperwork about their character to help understand their character's given circumstances. The aim of this paperwork is to help the actor with character development. Paperwork will also include your scored scripts.

Character Development Exercise- 100 points total: Using the *Small Mouth Sounds* by Bess Wohl, the actors will use the character descriptions to develop a character.

Short Quizzes- 200 points (4 Quizzes at 50 points each): The quizzes will be completed after reading the plays, book, and/or lecture. A pdf of the plays will be provided on MyLeo where the quiz will also be administered. <u>Quizzes are due</u> the same day they are administer. The quizzed will be multiple choice with one short answer question.

Midterm Performance- 125 points total: The midterm presentations will be the final product of weeks of rehearsals and in class workshops. Each student will perform a monologue from *Cat on a Hot Tin Roof* by Tennessee Williams.

Final Performance – 125 points total: The final presentations will be the final product of weeks of rehearsals and in class workshops. Each student will be paired with a partner in order to perform *Precipice* by William Mastrosimone.

Live Performance: 100 points total (2 at 50 points each): You are required to see two live theatrical productions this semester. You must turn in your program and ticket the Monday after the show closes to get your grade. We will talk about the performance extensively in class.

AUDITIONS: As a student in the acting class, you are required to audition for the Theatre Department's Season Show for the semester- ADDAMS FAMILY THE MUSICAL and IN THE WEST. Failure to audition will result in in the deduction of a total of 150 points (75 points for each audition) for the overall courses.

Extra Credit: No extra credit is offered for the course.

ATTENDANCE POLICY:

You may accumulate three (3) absences before any penalty occurs. There are no additional absences allowed without penalty. Plan accordingly. There is no such thing as an "excused" absence. Of course, if you have a prolonged illness or injury, or if a family emergency arises, speak with your instructor ASAP.

Grades will be dropped in 1/2 letter grade increments for every two class absences beyond three. (Example: Someone with an "A" average who misses class five times will be in the "A-" range; a seventh absence moves that student down into the "B+" range and so on...)

LATE ARRIVALS:

To further foster a high level of commitment—and because the work we will be doing this semester will involve intensive focus—the class will adopt the following late entry policy. Students must be on time for every class. Entering a class late or leaving early is disruptive to the flow of the class and indicative of a less than disciplined/committed student. Please be on time out of consideration to your learning process and the processes of others. If you arrive within the ten minute grace period, please do so discretely in order to avoid disrupting the class activities/discussions. It is your responsibility to make sure that you find me after class and document your late attendance for the day—otherwise, your initial marked absence documented during roll will remain. Also, you are expected to stay until you are dismissed from class. Two late arrivals (within the ten-minute grace period) or early departures (or any combination of the two) may be counted as one absence in the class.
