# **Course Description:**

This course is a survey of the principles and practice of the political system in Texas. In addition to examining the state constitution and the institutions that it empowers, a wider look is taken to consider local governments, the political system, and the actors in the political system.

# **Learning Objectives:**

- 1. Explain the origin and development of the Texas constitution.
- 2. Describe state and local political systems and their relationship with the federal government.
- 3. Describe separation of powers and checks and balances in both theory and practice in Texas.
- 4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas government.
- 5. Evaluate the role of public opinion, interest groups, and political parties in Texas.
- 6. Analyze the state and local election process.
- 7. Identify the rights and responsibilities of citizens.
- 8. Analyze issues, policies, and political culture of Texas.

## **Assignments and Grades:**

1. Examinations: There will be three examinations for a total of 300 points.

Each exam will be available for three days on D2L Brightspace. If you miss an exam, you will receive a 0 for that exam. If you are on a school related activity that requires you to be away for a significant period, you must contact me **prior to the exam** to reschedule. If you have a legitimate reason for not being able to complete the exam within those three days (illness, family emergency, etc), you may request a make-up exam upon providing supporting documentation. You are **not** guaranteed a make-up exam. Make-up exams are permitted at the sole discretion of the instructor. You should email me as soon as you know an exam may be missed.

Each exam will consist of 40 multiple-choice and fill-in-the-blank questions. You will be given 55 minutes to complete the exam in D2L Brightspace. If you experience technical issues, contact me immediately with as much information and any documentation, such as screenshots, as possible. Please refer to the *Technology Support* section for information on how to contact D2L Brightspace.

## 2. Discussions: 120 points.

For each chapter, discussion topics will be available on D2L Brightspace beginning at **7:00 AM CT on Monday** through **11:45 PM CT on Sunday.** There will be **no** make-up opportunities for **any** missed discussion posts. The deadline will be strictly enforced. Students will not receive any credit for posts submitted after the deadline. Students who consistently wait until the end of each time frame for posting their discussions will receive a grade deduction. There cannot be a true discussion if you do not provide your classmates time to respond.

Some topics may be controversial in nature. Polite discourse can be quite enlightening. Remember to be respectful. If you believe that someone has violated the Code of Student Conduct, contact me immediately. Do not respond to that person in anger or frustration. "If you can't say something nice, don't say nothing at all." (Bambi)

- Minimum Requirements:
  - One original post each chapter There is a minimum of two hundred words. If you fail to meet this minimum, you will receive a substantial deduction in your grade.
    - Original posts are due by 11:45 PM CT on Thursdays
  - Two response posts to other students There is a minimum of four sentences. A simple "I agree." or "Great job!" does not constitute enough effort to warrant credit. Critiquing your classmates on the technical aspects of their post, such as "Your post was too short." or "You did not answer the question." is not appropriate. Your responses need to be meaningful and contribute to the conversation.

If the topics ask you to explain the material covered in the chapter, you must explain the material covered in the chapter. If you do not cover the material appropriately, you may see a deduction in your grade. If the topics request an opinion, there is no wrong answer. You must support your opinion based true information. These do not have to strictly cover what was in the book. Please add your insights, incorporate relevant current events, etc.

**Bonus:** if you successfully post discussions every chapter of the semester that meet the minimum criteria, 10 points will be added to your grade.

## 3. Project: 80 points.

**This is NOT a group project.** Harold Lasswell defined politics as "Who Gets What, When, How." At the heart of politics is policy. You will be provided a list of policy issues on D2L Brightspace. In a PowerPoint presentation, you will offer the following regarding <u>one</u> of those key issues: why that issue was chosen, why that issue is important to the state, and how that issue is viewed from both the conservative and liberal perspective. More information regarding the assignment will be made available during the semester.

# 4. Attendance: <u>25 points</u>.

As we are scheduled to meet in person, students are required to attend class and attendance will be taken during each class session via a sign-in sheet. You may miss up to three class sessions on non-exam days without penalty. More than three absences will result in a reduction in your grade. If you are quarantined, you must log into D2L Brightspace at least two times per week to maintain your attendance grade. Failure to log in will count as an absence for purposes of attendance. The only absences that will not be counted against you are those directly related to school activities when someone from the department notifies the instructor of the student's activities. Documentation is not needed for any other absence as any absence that is not related to school activities is not "excused." If you have another student sign in for you, there will be serious repercussions. Please refer to the academic dishonesty section.

**Extra Credit Policy:** There will <u>not</u> be any individual opportunities for extra credit. All potential extra credit will be available only upon a class-wide basis. I do not "give" students a grade. Students **earn** their grade.

**Syllabus Change Policy:** As your instructor, I reserve the right to amend, modify, or adjust this syllabus as needed. Circumstances and events may make it necessary to alter the indicated schedule. Any adjustment(s) will be announced in class, on D2L Brightspace, and/or via email.

**Email Policy:** The **first** place to check for answers to any questions regarding class is this syllabus. Class policies and the calendar are clearly outlined. If you email me a question and the answer can be found in this syllabus, you will not receive a response. I attempt to respond to emails <u>Monday through Friday</u> within one business day. If I do not respond to you within two business days, please send a follow-up email as I may not have received your initial contact or speak with me before or after the next class period.
