Course Description

This course will provide students with key terminology, system concepts, and current cyber threats to organizations and individuals. The course provides a high-level overview of cybersecurity challenges and counter measures. It also introduces the Confidentiality, Integrity, and Availability (CIA) framework for designing and analyzing secure systems.

Student Learning Outcomes

Upon completing this course students should be able to:

- Understand the importance of information security / cybersecurity and associated risks
- · Learn the key concepts of information security
- Learn about some of the different domains and capabilities of information security including identity and access management, network security, application security, data protection, etc.
- Understand basic cryptography algorithms and mechanisms

- Learn and understand key concepts in threat & vulnerability management
- Learn concepts related to privacy & incidence response
- Understand basic cybersecurity issues related to emerging technologies (AI/ML, IoT, ICS/OT, 5G).

During this course, we will be using traditional and active learning methods, and work together using:
