Course Description

This course is a study of the themes that influenced all human cultures from the earliest times to the present, considered within the context of a comparative framework. Such themes as the impact of technological change on society, the development of means of economic exchange and the structure of religious and ideological systems will be examined. May be repeated for credit up to nine semester hours as topics change. Prerequisites: Non-majors may enroll with consent of department.

Specifically, this course will examine women's roles and experiences around the globe during World War II. Women supported, opposed, and resisted the war in many way – serving on the front lines, keeping the factories and farms afloat on the home front, as well as providing entertainment (not always on their own terms).

This course counts towards the Gender Studies Minor.

Student Learning Outcomes

1. Students will be able to understand the various roles of women during war.
2. Students will be able to understand the roles of gender and sexuality in history
3. Students will be able to apply knowledge of the interconnectedness of global dynamics

Student Responsibilities or Tips for Success in the Course

Attendance: As the instructor of this section, I allow students to attend class at their own discretion, but students should keep in mind that some assignments are in-class only and will not be eligible for make-up if missed. It is your responsibility to come to class prepared for lecture. If you miss a class it is your responsibility to gather class notes from a classmate. **I do take roll for administrative purposes.**

Electronics Policy: Our class is a time for learning and discussion. Cell phones and other devices should be turned off during class – unless otherwise specified for an in-class activity. Airplane mode is preferred. If you are using a laptop/tablet, it should be used solely for note taking. If I feel you are using your devices for something other than taking notes you will be asked to power the device down.

Student Behavior: Behavior which may result in your being asked to leave my class includes, but is not limited to: sleeping, talking during lectures, movies or clips, text messaging, gaming, playing with your phone, using electronic devices other than for specified activities, and working on another course's work/homework during my class.

Expectations for Out-of-Class Study: Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional 9 hours per week of their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.

GRADING

Grading: This course is based on the 100-point system. All assignments are worth 100 points. The final exam is weighted the same as the other exams. I do not round up. If you earn an 89.9 you will receive a B for the course.

Final grades are determined on the following scale:

100 –90 = A, 89 –80 = B, 79 –70 = C, 69 –60 = D, 59 and below = F

Assessments

There will be weekly reading from the assigned texts as well as additional materials posted in D2L. This course has two (2) take home written essay exams, one (1) research paper, three (3) reading response papers, and one (1) final reflection paper and discussion. I also assess you professionalism and course engagement.

Weight of major assignments and examinations for this course are as follows:

• Classroom professionalism and course engagement:	20%
• Reading response papers – three (3) total:	20%
• Research paper (and its components)	50%
• <u>Final reflection paper and discussion:</u>	10%

If you have a problem with a due date because of a specific emergency, please notify the professor in advance or plan to turn the assignment in early. *I can be very understanding and flexible with you, but only if you come to talk to me in advance (when possible).* To pass this class, all assignments must be completed. Any missing assignments at the end of the course will receive a grade of F.

Academic Honesty

In all courses, we expect that all work that you do and turn in is your own.
