COURSE INFORMATION

Course Description

Stage Combat 1: Stage combat is an essential tool for actors across genres. The goal of this course is to provide a set of skills to present the **illusion** of physical conflict on stage, in a safe and believable manner. An exploration of threat, action, reaction and pursuit of objective through staged combat, inclusive of 30 hours of training and an option to test for certification in unarmed combat with the Society of American Fight Directors. This is a performance class and will evaluate student's ability to safely perform the course material in front of a live audience.

Student Learning Outcomes

The student will leave armed with a foundation of knowledge to enhance their acting skillset:

- A basic knowledge of unarmed staged combat techniques as demonstrated through:
 - Execution of choreographed staged combat performance as applied to given text and/or scenes

- Capability in partnering and sharing action within a staged sequence through demonstration of technique
- o Familiarity with unarmed stage combat technique vocabulary
- Awareness of communication techniques for onstage performance displayed through practical demonstration
 - o Ability to navigate cue and response within given choreography
- Pursuance of objective and intention within physical storytelling
 - o Scenic analysis tools to support storytelling through physical demonstration
- Awareness of vocabulary consistent with the Society of American Fight Directors' Skills Proficiency requirements for unarmed stage combat

 - o Please do not wear heavy scents (cologne or perfume).

- Daily warm-ups are mandatory and are considered a requirement for classroom participation.

Written Assignments and Presentations

Choreography Assignment One: A sequence combining moves already demonstrated within class, with addition of intention and stakes

Scenic Analysis Assignment: A written exploration of a provided scene, complete with action/reaction and want/skill/awareness for each character

Midterm:

Paper: Student will choose a scene to analyze violence from the perspective of each character, its place within the narrative, and critical observations to its impact on the overall story (1-2 pages)

Demonstration: Student will demonstrate previously taught techniques in a classroom evaluation

Performance: Performance of Scenes

Choreography Assignment Two: A three-phrase sequence utilizing techniques given in class, with emphasis on character, story, and impact of violence

FINAL:

Paper: A reflection on the entire semester, student will analyze violent storytelling in theater based on a chosen scene. Part One will be a full scenic analysis. Part Two will be a self-evaluation (3-5 pages)

Demonstration: Student will demonstrate previously taught techniques in a classroom evaluation

Performance: Performance of scenes
