**COURSE DESCRIPTION AND OUTCOMES**

Students will become acquainted with the general historical development of art from the Prehistoric period to Contemporary Art. The course will introduce basic tools and terminology used in discussing artworks. We will explore art and artifact contextually – through culture, language, politics, and location, as well as techniques and production, to better begin to truly see and understand what makes this work so essential. We will look at the ways that art had introduced and developed technology, while illustrating the advances of civilization. This class will require students to *discuss* a number of images that represent the historical span of the course and to *demonstrate the analytical skills* necessary to communicate visual information. By the end of the course you should not only be able to discuss historically significant works of art, but also be acquainted with the characteristic features of the art and culture from major historical periods.

**COURSE OBJECTIVES**

- understand definitions of important art and art historical terminology
- discuss and explain historically significant works of art
- analyze significant styles and movements within art history and including a variety of types of media
- enhance visual literacy and critical thinking skills

**ASSESSMENT:**

Students' ability to meet the course objectives and learning outcomes will be evaluated through written assignments, discussion posts, worksheets, projects, and essays.

**WORKLOAD:**

The rule of thumb for time required for course study and preparation each week for a face-to-face class or an online course during the spring and fall semesters is three times the number of credit hours (or 9 hours per week) for the course. If you find yourself unable to complete course requirements in a timely manner, refer to the University's withdrawal policy and the appropriate dates. ## COURSE REQUIREMENTS:\*

**Participation:** Each person is expected to be prepared for the class, which means having completed the reading and/or viewing the film screening and completed the assignments. Responding to classmates blog entries and discussions is a pivotal and key part of each of the assignments for the course.

**Discussion:** Each student will write numerous times to the discussion page for the class. There will be clear class prompts, with word counts for you to follow.

**Book Essays:** At various points throughout the class, you will be given questions asking you to respond to the reading. These will require you to develop your writing skills and respond to challenging and unique questions the readings present.

**Study Guides:** For each section of material covered you will produce a study guide, filled with the important facts and key information covered. You will focus on defining new terminology, and creating a document that summarizes the material.

### **Visual Essay Project:**

At the end of the course, each student will create a document that compares a number of different images seen throughout the course and in their everyday life. Thoughtfully, the student will choose artwork and film/television stills to address a theme that they are interested in that aligns with the course material. Further, each student will respond to each of their classmates work.

**Assignments will NOT be accepted over TWO DAYS late.** For each class day late, the grade will be reduced by ½ a letter grade.

### **Grade Breakdown:**

Book Essays: 30% (10% each)
