## **Course Description:**

Schools serve as a critical system of support for children who have experienced trauma. This course will provide school professionals with strategies of how to create trauma-informed environments (schools and classrooms) that mitigate against the impacts of trauma. This course was designed for administrators, teachers and school staff to recognize trauma responses, to recognize practices that may cause traumatic stress or re-traumatize students, to accommodate and respond to traumatized students within the school setting including referrals to mental health professionals when necessary. This course will take a deep dive into the empirical research on how trauma, including adverse childhood experiences (ACE), impacts children and their experiences with formal schooling.

Additionally, through this course, participants will be introduced to and explore best practices that assist students in developing positive relationships that can help them to recover and respond resiliently to future adversities. State, district and local school policies and procedures implemented/adopted by Texas schools that strengthen students' interpersonal relationship and emotional skills as well as practices that support students' physical and mental health needs will be critically examined.

## **Course Pace—Winter Mini**

The content in this course will be covered in approximately 3.5 weeks. You will be expected to submit all assignments on time as indicated in the course syllabus and in the course shell. Although there will be a reduction in the number of weeks in this short semester, **the quantity of work remains the same as would be required in a regular semester**. Reductions in course readings and/or assignments are not permitted as you will be granted 3 credits at the conclusion of this course should you perform satisfactorily on all assignments.

# **Course Learning Outcomes**

## Upon completion of the course, the student will:

- Attain a basic understanding of how trauma affects the brain and the nervous system
- Identify common indicators of trauma
- Understand the implications of these effects on learning and on students in an educational setting
- Explain how a student's behavior, social-emotional well-being, and academics are impacted by trauma
- Recognize commonly used strategies that hinder a trauma-affected student's ability to succeed

# **COURSE REQUIREMENTS**

## Minimal Technical Skills Needed

Students will need to have access to a computer with Internet (high-speed preferred), access to a Webcam, and document productivity software (Microsoft Office preferred). Additional skills needed are using the new learning management system, using Microsoft Word and PowerPoint for presentation a graphics programs.

#### **Instructional Methods**

This class design is based on constructivist learning principles. This means that the instructor creates an environment for learning by providing focus and guidance to the content. Assignments are designed to be learning experiences for students, and it is presumed and expected that students actively participate in the class through the construction of their own learning. As a graduate level course, the instructor expects quality work from each student supported by adequate preparation and involvement. Instructional activities and assignments will be delivered and received online using the D2L learning media platform.

Student Responsibilities or Tips for Success in the Course When sending emails to me, please include your name and Course Number in the subject line. Students are expected to take responsibility for their own learning process. While the online course includes interactions between students and instructor and students and students, they are not immediate as a face-to-face course. Students must be comfortable waiting up to 24 hours for a response to their emails.

- 7. Reading and responding (by the due date) to the discussion post of fellow peers.
- 8. Completing and sending an assignment (by the due date) to be graded by the instructor.
- 9. Revising and re-writing written assignments. Writing is an iterative process.
