Course Description

The purpose of this course is to facilitate the learning of talent development practices in the real world. This course investigates the theoretical foundations of specific talent development practices with a special emphasis on the ways in which these practices are represented in films. The focus will be on people analytics, mentoring, and career development which has significant implications for workplace learning, performance improvement, employee engagement, and a host of related topics.

Student Learning Outcomes

- Demonstrate knowledge regarding theoretical foundations of talent development practices in the contemporary organization
- Analyze and interpret talent development practices based on the concepts of talent development
- Apply theoretical foundations of talent development to solve talent development issues in the workplace.

Course Grade

Weekly discussion (3 at 100 points each): Online discussions will serve as a comprehension check on selected topics.

Reflection paper/Article abstract (1 at 100 points each): Each student will prepare a reflection paper of an abstract of a research article that is related to the focus of this class.

Final project (800 points): Each student will find media clips that can illustrate talent development practices. Apply the talent development practices into their current organization to improve individual and organizational performances.
