Course Description

ENG 1302 - GLB/US-Written Argument/Research Hours: 3

This course provides students with advanced training in communication skills emphasizing the writing and reading of argumentative prose and adapting writing to alternate audiences. Students will write weekly, including such texts as journals, reading responses, summaries of argumentative texts, argumentative papers, and longer papers integrating secondary research. Activities include close reading of sample texts, both student and professional. Some sections will emphasize special topics in both reading and writing. Prerequisites: Grade of C or better in English 1301 or advanced placement or CLEP.

Student Learning Outcomes

- 1. Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.
- 2. In written, oral, and/or visual communication, A&M-Commerce students will communicate in a manner appropriate to audience and occasion, with an evident message and organizational structure.
- 3. Students will be able to work together toward a shared purpose relevant to the course or discipline with a sense of shared responsibility for meeting that purpose.
- 4. Students will understand and practice academic honesty.
- 5. Students will be able to view themselves as engaged citizens within an interconnected and diverse world.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

You will need:

- Flash drive or other means (dropbox.com account, for example) of storing digital versions of the essays and other written material you generate (always, always keep a backup of everything you turn in!)
- o A valid, working email address that you check often (everyday). I will email the class through D2L, so be sure that that email is the one you check.

- Access to a computer with a word processing program and a printer (assignments must be typed uploaded through D2L in a doc or docx file)

Instructional Methods

This will be an in-person course with lectures during class times. You will be expected to come to class and participate in all in class work as well as using Top Hat online for readings and answering questions about those readings. While this is a fully in person course there will still be various online components and you should check D2L and your email frequently.

Student Responsibilities or Tips for Success in the Course

It is expected that you will participate in Top Hat every week, usually on multiple occasions. All students should check their email daily and log into D2L at a minimum 2-3 times a week. To succeed in this course, you should also complete all the required reading and activities in Top Hat.

COURSE AND UNIVERSITY PROCEDURES/POLICIES

Course Specific Procedures/Policies

Attendance: You're expected to attend class in person for every class period that you are able to. As you may have noticed in the Assessment and grading breakdown, attendance in class directly affects your overall grade in the class so please keep that in mind. If you do not attend class without giving me a reason for your absence ahead of time, you will receive a 0 for that day's attendance grade. Exemptions will be made for athletes who must miss class for their athletic events with the university or any other student who must miss class for a university sanctioned event with band/clubs/etc. If you are sick for any reason (regardless if it is actually Covid or not) I would also encourage you to stay home and let me know that you are unable to attend class and I will also excuse your absence for the day. But again, you must let me know by email before that day's class for this. A doctor's note is **not** required.

Cell Phones and other distractions: I will allow you to have your phones out during class, all I ask is that if you use them, you do not distract me or other students. Some examples of this being, watching a video in class with the sound on, listening to music so loudly that it can be heard through your ear buds, taking a phone call and having your conversation in class. I understand that sometimes you may receive important class, I simply ask that if you must take a call during class, you step out into the hall, have your conversation as quietly as possible, and return to class when you are done. If you are being a distraction, I will ask you stop once, and if you become a distraction with your phone a second time you will be asked to leave and you will receive a 0 for attendance for that day. This "distraction" policy also applies to other things such as talking to other classmates during class about something unrelated to class.

Late Work: Every major assignment will have a set due date unless I decide to change it. Work must be turned in by the set due date or you will receive a grade penalty for the late assignment. The penalty starts at -10 points for turning it during the first week after the initial due date. An additional -5 point penalty will be added for every week after the first that it is late so please make sure you turn your assignments in on time. Exceptions

can be made but you must inform me of why you are unable to submit an assignment on time at least 24 hours **before** the due date.
