#### COURSE DESCRIPTION

The Visual Art segment of the course is an introduction to teaching the discipline of Art at the elementary level, concentrating on the integration of the art elements and principles of design within the regular curriculum.

# **COURSE OBJECTIVES** Student Learning Outcomes

- 1. To develop critical thinking skills, conceptual constructs, specialized vocabulary and art history through the study of the human figure
- 2. To learn to draw the human figure in an objectively accurate manner
- 3. To develop manipulative, work-oriented skills and demonstration of specific process skills and mastery of mediums
- 4. To develop the ability to carry out directions, meet deadlines, meet attendance requirements, come to class prepared, show respectful attitude towards all, maintain work area

# COURSE REQUIREMENTS Minimal Technical Skills Needed

Using D2L Brightspace learning management system, Microsoft Word, Microsoft PowerPoint.

Course Instruction Methods and Student Expectations:

This course will require both reading material located in the D2L classroom, weekly reading assignments, and viewing of online videos. Assignments will include writing assignments, creative art projects, slide presentation, and quizzes.

- You will need a computer or other device to access D2L for course content and to turn in assignments and quizzes.

#### **Instructional Methods**

A. Chapters 3, 6 & 7 (required reading). PowerPoint group slide presentation, lesson plan- Microsoft.

B. The Elements of Art & The Principles of Design

Studio projects: Sketchbook To develop awareness and sensitivity to natural and manmade environments. This area covers the students' visual and aesthetic observation and critical thinking skills.

- C. To learn a verbal and visual vocabulary that is relevant to art.
- D. To express inventive and imaginative ideas, thoughts, feelings through art media, tools, and techniques. This area helps students develop a growing ability to express creatively and helps increase knowledge of art production skills.
- E. To be introduced to an understanding of self and others through the study of art, culture and heritage. This area helps students develop awareness of our cultural differences and the importance of art in various cultures.
- F. To become acquainted with aesthetic growth through visual discrimination and judgment. The elements in this area are concerned with developing informed judgments about art through art criticism.
- G. To understand the importance of integrating art into the classroom, and to understand how appropriate art projects develop problem solving and critical analysis in student learning.
- C. Portfolio- Painting, Drawing, Printmaking, Collage, Sculpture.
- D. Group oral presentation of Integrated lesson plans. The course fee will cover the cost of art supplies and materials used in class. You will need to purchase materials needed for the oral presentation of the integrated lesson. You will need to make enough copies of your presentation lesson plan for everyone in class.

#### Focus:

- 1. Class participation and involvement in critiques.
- 2. Dedication to class studio work and homework.
- 3. Dedication to self-directed and group work.
- 4. Experimentation and demonstrated understanding of visual concepts.
- 5. Quality of work and presentation.
- 6. Demonstrated understanding of key concepts presented in class as it applies to development of an integrated curriculum.
- 7. Excellent attitude, attendance, promptness, timeliness, maintenance and cleanup of work area.

# Student Responsibilities or Tips for Success in the Course

- Excellent attendance & promptness. More than three unexcused absences will adversely affect grade. A tardy will count as half an absence, as will leaving class early. Excused absences will be considered due to illness with a doctor's note, or due to a death in the family. Any other extenuating urgent circumstances should be discussed with the instructor. More than 6 unexcused absences for the course will result in a student being administratively dropped.
- Following directions on given assignments

- Positive attitude, degree of involvement, contributions to class discussions. Any disruptive activity will result in the student being escorted from class and administratively dropped.
- Dedicated scholarship in class work, paper, presentation, and homework.
- Understanding of visual and art historical concepts.
- Professionalism. Come to class prepared. Phones must be put away and turned off. No headphones.
- Completion of assignments by the given deadline.
- Control and mastery of art media and techniques.
- Quality and improvement in work.
- Craftsmanship, creativity, and presentation.
- Regularly check D2L for announcements, grades, etc.

#### **GRADING**

Final grades in this course will be based on the following scale:

Your average in the art segment will be based on:

- Test grade- 25%
- Portfolio of studio work- 25%
- Group integrated lesson plan and presentation- 30%
- -Daily Grade: includes preparedness for assignments in class and for homework, class participation, attendance (unless excused), attitude, maintenance of work area -20%

Your average in the art segment will total points = 600 points, comprising 25 % of the entire grade for the semester.

The average grade for the course will be based on your art, theatre, music grades, and your score on the final exam (which is comprehensive and covers the entire textbook-- worth 200 points).

Leaving early is the same as a tardy. 10 points will be deducted from your daily studio time for late arrival or leaving early. Regular attendance is expected.
