Course Description

ECE 366 provides a study of Early Childhood organizational plans, procedures, physical facilities, and a survey of materials and equipment. This course develops a process of designing appropriate learning environments for young children.

<u>Student Learning Outcomes</u>: This ECE 366 class is listed by the University as an Early Childhood Education course to enable students:

- To equip and supply an Early Childhood classroom (TEA Competency 2.19k: To
 equip and supply so that features and characteristics of physical spaces that are
 safe and productive for learning; observable by the instructor and measured via
 course assessments)
- 4. To plan and organize a child-centered environment (TEA Competency 2.6s: To plan, organize, and establish classroom rules and procedures to promote an organized and productive learning environment; observable by the instructor and measured via course assessments)
- To build communication skills with parents and paraprofessionals (TEA Competency 4.1s: To interact appropriately with families that have diverse characteristics, backgrounds, and needs; observable by the instructor and measured via course assessments)
- 6. To associate ECE TEXES competencies with course content (TEA Competency 1.6s: To use the Texas Essential Knowledge and Skills which are the TEKS to plan instruction; observable by the instructor and measured via course assessments)

COURSE REQUIREMENTS

Minimal Technical Skills Needed

You will need a PC, laptop computer, etc. with Microsoft Word for this course and access to your university email and the university my Leo D2L Brightspace online learning system.

Instructional Methods

This course is composed of a series of assignment and assessments (Mid Term Exam and Final Exam) to assist students in achieving the Student Learning Outcomes. Each week, you will work on various combinations of assignments, online discussions, chapter readings, and/or research articles and educational videos.

Student Responsibilities or Tips for Success in the Course

In order to attain success in this course, the student's responsibilities are the following: (1) The learner will read, study, and review each chapter of the course textbook as assignment by the instructor. (2) The learner will successfully complete the Mid Term Exam and the Final Exam (worth: a possible score of 100 for each exam). (3) The learner will complete the Critical Assignment and the 3 Key Assignments (worth: a possible score of 100 for each assignment). (4) The learner will be an active and engaged participant in D2L Brightspace discussions as assigned by the instructor, and other course related activities by analyzing, constructing/creating, and evaluating information presented within the course textbook, online readings/resources, and educational videos (worth: possible score of 100 per activity). (5) The learner will adhere to the University's Attendance Policy and be in attendance and on time at each online scheduled Discussion activity. (6) The learner will not engage in any forms of "plagiarism" and/or "cheating" to complete course requirements and/or exams; all online and outside sources must be cited at the end of each assignment. (7) The learner will submit all exams, assignments, and complete all discussions by or on the specific due dates and times; late work will not be accepted with the exceptions of illness, child's illness, husband or wife's illness, immediate family funeral (must be accompanied with a documented medical excuse note or funeral or memorial notification). Connection and/or computer or laptop problems are not excuses for late submissions. Therefore, you will need backup resources in order to submit your coursework on time should connection or other problems occur. (8) Each student should check their university email often and respond to the instructor in a timely manner; DO NOT IGNORE messages from the instructor; messages from the instructor will be sent via the university email system and/or D2L Brightspace.
