

Exams

Assignments

Weekly Discussion Posts /In Class Activities (10):

After reading each chapter, respond to the week's prompt in the discussion board. *Note: there will be no discussion posts required during weeks that have other assignments or exams due.*

Multicultural Assignment:

In this assignment, students will reflect upon the social model of disability and the medical model of disability, as well as asset-based and deficit based approaches to education.

Universal Design for Learning Assignment:

Using the introductory video and UDL guidelines found on the website for the Center for Applied Special Technology (CAST), students will explore one of the three areas of the UDL framework: Engagement, Representation, or Action & Expression.

Film Analysis

This assignment will allow students to analyze how society experiences "disability" as it is portrayed in film. Please note, this is NOT a review of a film and cannot be downloaded from the film's website. There are specific questions to be addressed in your analysis:

- Summary of film
- Critique of the film
- Your analysis
 - Emótional Response
 - o Portrayal
 - Filmmaking
 - Cultural Response
