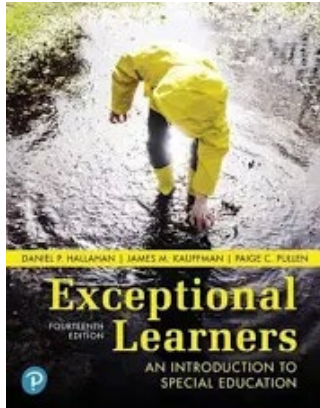

### **Course Description:**

The course will provide a survey of populations with exceptionalities. Attention will be given to the cause of these deviations and their effect upon the individual's development. Professional roles of the special education team member as well as the policies and regulations applicable to special education programs in general will be covered.

### Exams

**Exams:** Three objective exams will be given on the scheduled dates. Tests will be taken in D2L (my Leo), and will be randomized to each user. You will have one-attempt at each test. You will have unlimited time to take the exam. **There will be NO MAKEUP opportunities for missed tests.** However, if there is a technical issue, those will be handled on a case-by-case basis.

### Assignments

#### **Weekly Discussion Posts /In Class Activities (10):**

After reading each chapter, respond to the week's prompt in the discussion board. *Note: there will be no discussion posts required during weeks that have other assignments or exams due.*

## **Multicultural Assignment:**

In this assignment, students will reflect upon the social model of disability and the medical model of disability, as well as asset-based and deficit based approaches to education.

## **Universal Design for Learning Assignment:**

Using the introductory video and UDL guidelines found on the website for the Center for Applied Special Technology (CAST), students will explore one of the three areas of the UDL framework: Engagement, Representation, or Action & Expression.

## **Film Analysis**

This assignment will allow students to analyze how society experiences “disability” as it is portrayed in film. Please note, this is NOT a review of a film and cannot be downloaded from the film’s website. There are specific questions to be addressed in your analysis:

- Summary of film
- Critique of the film
- Your analysis
  - Emotional Response
  - Portrayal
  - Filmmaking
  - Cultural Response
