COURSE DESCRIPTION

This is the second part of a two-semester course in Real Analysis. Topics include real number system; sequences and series; limit, continuity, and differentiation;

the Riemann integral; sequences and series of functions; elementary metric space theory including compactness, connectedness, and completeness; differentiation and integration of functions of several variables.

STUDENT LEARNING OUTCOMES

By the end of the course, students should be able to **determine** the Riemann integrability of a bounded function and prove a selection of theorems concerning integration; **recognize** the difference between pointwise and uniform convergence of a sequence of functions; **illustrate** the effect of uniform convergence on the limit function with respect to continuity, differentiability, and integrability; **recognize** metric spaces and **utilize** their arguments to obtain a variety of results; **extend** the ideas in differential calculus which is to approximate functions by lines and linear functions to higher real dimensions; **understand** and **use** Inverse and Implicit function theorem; **define** the Riemann integral using the Darboux upper and lower integrals; **employ** iterated integrals and Fubini theorem; **comprehend** and **make use of** outer measure, null sets, the set of Riemann Integrable Functions, and Jordan Measurable sets; **write** solutions to problems and proofs of theorems that meet rigorous standards based on content, organization and coherence, argument and support, and style and mechanics.

COURSE REQUIREMENTS

Course Evaluation Methods

This course will utilize the following instruments to determine student grades and proficiency of the learning outcomes for the course.

Exam – (proctored) There will be one in-term Exam and a Comprehensive Final Exam.

You will have a period of 120 minutes to complete an exam. Each Exam will be proctored through ZOOM. The ZOOM link to the Virtual Exam room will be provided in advance. **You need to have a webcam and a microphone to take an exam, both in working conditions.**

Mid-term exam date: Thursday, March 3rd (Week #8) starts at 5 pm (120 minutes)

A make-up Exam is possible only if there is a documented emergency.

Final Exam: (proctored) A Comprehensive Final Exam (120 minutes).

Final Exam Date: Monday, May 9th starts at 5 pm

Attendance: Online attendance is required. It is critical you keep up with the pace of this class. A term goes quickly. Once you are behind our pace, you can easily get lost. I strongly suggest you study ahead of our pace continuously review the material. Online attendance in this course is determined by your log-in and participation in our course in D2L.

Attendance means students will watch posted videos, join online discussions, and submit required homework assignments on time.

Homework: There will be weekly homework assignments. Each assignment will be graded. Missed questions and answers without work do not earn credit. Each homework assignment's questions will be posted on the weekly module assignment under D2L. The due date for each assignment will be announced with the assignment. Late homework submission will not be accepted.

The homework assignment you submit must be your own work. Plagiarism is strictly prohibited.
