Your course grade will be determined on the basis of your performance in each of the following areas:

1. On line discussions- 7.5% Each- Watch the assigned YouTube link in D2L and then write at least 350 words responding to the video. **(Due February 13 & February 27)**.
2. Bullying Testimonial Response- 10%-- Find a YouTube Video of a bullying testimonial. This could be a Ted Talk of how bullying played a role in the person's life or how it resulted in the loss of a life. It can pertain to anything as long as Bullying is the main idea. Write a one-page summary of the video. Times New Roman, 12 pt. font, Double Spaced.

3. Journal article annotated bibliography 25% -- The annotated journal bibliography must be word processed or typed double-spaced and adhere to APA publication format. A part of the evaluation will involve assessment against APA format as well as clarity of written form and grammatical accuracy. All papers will be retained by the instructor; therefore, it is suggested that each student retain a copy of their work. Please take note of the due dates listed below for the journal article manuscript. The final grade of this project will be adversely affected by any work submitted late. **(Due March 6)**
4. Exams 25% each -- There will be TWO exams covering the text and the code of ethics. Examinations may consist of multiple choice, matching, or short answer.
