Course Description (3 semester credit hours)

This course focuses on general principles of pharmacology including pharmacokinetics, pharmacodynamics as they relate to the treatment and management of common illnesses and conditions across the lifespan. Attention is given to the physiologic basis and clinical characteristics of disease states relative to pharmacotherapy. Clinical decision-making and review of laws governing prescriptive authority for advance practice nursing are also emphasized.

Student Learning Outcomes

Upon completion of the course, the student will have been given the opportunity to:

1. Discuss the pharmacodynamics and pharmacokinetics of a variety of drugs used to treat primary care conditions throughout the lifespan. (AACN MSN Essential I)
2. Integrate pathophysiology, physiology, and pharmacotherapeutics into advanced clinical nursing practice. (AACN MSN Essential I)
3. For a given disease state, discuss pharmaceutical options, develop a therapeutic regimen that maximizes effectiveness while minimizing adverse reactions, provide appropriate patient education, and evaluate the response of the patient to the therapeutic agent. (AACN MSN Essential VIII)
4. Demonstrate clinical application of the pharmacology content through case study presentation. (AACN MSN Essential IV)
5. Identify pregnancy and lactation categorization of drugs and their indications for clinical use in that population. (AACN MSN Essential III)

6. Integrate knowledge of over-the-counter medications, vitamins, minerals, and alternative medicine in clinical practice anticipating potential drug-to-drug interactions. (AACN MSN Essential I)
7. Understand the professional and legal aspects of the advanced practice nurse in prescribing and managing pharmacological therapy, recognizing the advanced practice nurses' accountability, responsibility, and scope of practice. (AACN MSN Essential IX)
8. Demonstrate how to correctly write a prescription, including all appropriate elements. (AACN MSN Essential V)

Students must achieve a minimum average of 80% on exams in order to pass the course. Other graded assignments will not be added to the final grade unless exam grade average is 80% or higher.

Successful completion of the examinations and other required assignments will enable the student to meet the student learning outcomes.

Assessments

Exam: Exams will be an on campus proctored and timed assessment of the units specified in the course schedule. A student who is unable to take the scheduled exam must notify the instructor prior to the start of the exam to determine whether a make-up is available. **Students must achieve a minimum average of 80% on exams in order to pass the course. If an 80% exam average is achieved, then all other assignment grades will be added to the final course grade.** (Student outcomes 1-3, 5-8)

Concept Prescribing Modules: A solid foundation of the pathophysiology of disease states, pharmacodynamics, pharmacokinetics, drug side effects, and interactions is crucial for patient safety. The assigned prescribing modules help prepare the student for these concepts and other considerations in patient safety when prescribing medications. There will be concept modules for students to familiarize themselves in Shadow Health. (Student outcomes 1, 4, 8)

Pharmacology Presentation: A presentation will be made to post on the discussion board. You are responsible to answer any questions posted under your presentation for that week. Topics will be a new medication within the last 3-5 years of Instructors approval/assignment.

Shadow Health Clinical Simulations: Assignments are the 6 Focused Exams Grading is pass/fail; however, you must achieve a DCE score of 80% or higher on the Focused Exams. You will have multiple attempts to achieve your score. Each module will only be due on the topic week in the course schedule. The lab pass is to be downloaded and submitted in the assignment link in the course. There are no DCE scores for Concept Labs, they are pass/fail. (Student outcomes 1-8)
