Course Description

This course covers the development of new theatrical scripts based on existing stories and source material. Students explore a variety of potential source materials, develop adaptation ideas from multiple sources, and complete a written script.

Student Learning Outcomes

- 1. The student will be able to understand the basic tenets of playwriting within theparameters of a dramatic work.
- 2. The student will be understand the process both creative and legal of writing adaptations for the stage.
- 3. The student will be able to participate as a professional in workshops with both theirown and other students' works.
- 4. The student will be able to complete a complete draft of an adaptation.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students must have access to a computer and the ability to use Microsoft Word or other word processing software. Students must also be familiar with how to use the D2L Brightspace platform including uploading documents to Dropbox as .pdfs.

Instructional Methods

Students will be graded on a series of reading selections, class projects, practical application of the knowledge that they have learned, the completion of a draft of dramatic work, as well as in class discussion and exams.

Student Responsibilities or Tips for Success in the Course

- 1. Be on time.
- 2. Be prepared. Read what needs to be read. Write what needs to be written.
- 3. Participate. There is a great deal of exciting discussion in this course, and it will be even more exciting with your ideas.

Assessments

Short Writing Assignments: Through the first half of the semester at least once a week I will assign a short writing assignment based on a prompt given in class. Often you will have class time to begin writing. They will be due, typed and formatted correctly, on D2L each Sunday night by midnight.

Discussion/Participation: This is not simply about showing up but about being involved in the class discussion and participating as a respectful collaborator. The largest part of this grade will be related to your participation during in class readings/workshops of your and your classmates plays. Guidelines for the workshops will be provided in class.

A Doll's House Part 2 Response: Students will watch a production of OR read the script for A Doll's House by Henrik Ibsen and then watch the TAMU-C Playhouse Production of A Doll's House Part 2. Students will write a 700 word response comparing the two works. More details will be provided in class.

Complete Draft of Adaptation: At midterms, each student will choose from their short writing assignments the beginnings a short play (15-30 pages). The second half of the semester will be spent developing that play through writing in and out of class as well as in class readings/workshops. The final assignment for this course, due on the last day of class, will be a complete draft of the play. Further instructions will be given inclass.
