# **Course Description**

This course covers different aspects of financial markets, institutions, and instruments. The course begins with an overview of structure and functions of financial markets and institutions as we consider the role of political, social, legal, and regulatory forces in financial decision making. The course will expose students to changing global financial conditions and ethical consideration in real world.

### **Course Learning Outcomes**

At the conclusion of the course the students will be able to reflect:

- 1. An understanding of financial markets and the institutions that operate in these financial markets.
- 2. An understanding of mechanics of operation of the whole financial system.
- 3. Analyze the impact of global financial conditions and consequences thereof.
