#### SAFETY AND HEALTH PROGRAM DESCRIPTION

The Bachelor of Applied Arts and Sciences in Safety and Health (SHCB) degree is a competency-based program that prepares innovative leaders for employment in an increasingly technological and global society. This program provides opportunities for students to receive credit for what they know and can do already, allows them to accelerate completion of their degree, and — because it is fully online — students are able to plan their study schedule around the rest of their day to complete the coursework.

## **COURSE DESCRIPTION**

This course reviews and analyzes laws affecting workplaces, including the Clean Water Act, Clean Air Act, RCRA, and CERCLA. Students also study these laws and related policies and practices as they are related to safety.

## STUDENT LEARNING OUTCOMES

Completion of this course provides the student with the knowledge to:

1. Identify environmental laws and regulations applicable to a given workplace.

- 2. Identify governmental agencies in charge of regulation and enforcement of environmental laws.
- 3. Understand how compliance with environmental laws affects safety at the workplace.
- 4. Understand how violations of environmental laws affect the community.

## REGULAR AND SUBSTANTIVE COURSE INTERACTION

As a general guide, students enrolled in a three-semester-hour course should spend one hour engaged in instructional activities and two to three hours on out-of-class work per week in a traditional semester. Students are expected to double this effort of engagement given that this course is being delivered in a seven-week term. Educational activities in this course are designed to ensure regular and substantive interaction between students and faculty to ensure that students are able to demonstrate competency.

# **Learning Objective Essays**

Essays are submitted to the instructor and do not require comments or "discussion" with other students in the course.

# **Learning Objective Quizzes**

A brief assessment at the end of each module that is intended to emphasize key concepts, theories, processes, etc., introduced in the Learning Objective Module.

#### **Course Post-test**

The end-of-course comprehensive exam that assesses student knowledge and understanding of major concepts, theories, processes, etc., in the course. A **score of 80% or higher is required** to demonstrate competency.

If you score less than 80% on the post-test, you will have an opportunity to review the material and retake the post-test two additional times. If the posttest score is less than 80% within three attempts, students will receive a grade of "F" in the course and will be required to retake the course in the new term. Students who fail the posttest should review feedback from the instructor before reattempting the posttest.

## **Culminating Project**

The project assesses your knowledge of terms and the application of concepts presented in this course. A **score of 80% or higher is required** to demonstrate competency.
