Course Description

Exploring a career in social work is a bachelor's level elective that will allow students to explore different career opportunities for social workers. This course will include interviews with licensed social workers who are currently practicing in the field, relevant videos, and readings on various topics such as social work values and ethics and how to become a social worker in Texas. In addition, this course will highlight the importance of social workers and the profession's impact on society.

PROGRAM GOALS:

- 1. Prepare BSW students for professional practice that reflects application and integration of critical thinking, theoretical frameworks, and differential interventions.
- 2. Enable BSW students to be able to demonstrate reasoning to advance equality, justice, and social change.
- 3. Promote leadership and service that is relevant to individual contexts of practice and enhances well-being and quality of life.

CORE COMPETENCIES

Council on Social Work Education (CSWE) requires a competency-based approach to identify and assess what students demonstrate in practice. In social work, this approach involves assessing students' ability to demonstrate the competencies identified in the educational policy. Students to achieve programmatic goals listed above through demonstration the following nine competencies for generalist-level practice.

Competency 2.1.1 Identify as a professional social worker and conduct oneself accordingly

Competency 2.1.2 Apply social work ethical principles to guide professional practice Competency 2.1.3 Apply Critical thinking to inform and communicate professional judgments

Competency 2.1.4 Engage in diversity and difference in practice

Competency 2.1.5 Advance human rights and social and economic justice

Competency 2.1.6 Engage in research-informed practice and practice-informed research

Competency 2.1.7 Apply knowledge of human behavior and the social environment

Competency 2.1.8 Engage in policy practice to advance well-being and deliver services

Competency 2.1.9 Respond to contexts that shape practice

Competency 2.1.10 (a)-(d) Engages, assesses, intervenes and evaluates individual, families, groups, organizations, and communities

Student Learning Outcomes (Practice Behaviors)

Each competency (outlined above) describes the knowledge, values, skills and cognitive and affective processes that compromise the competency at the generalist level of practice. While content and activities of each course in the BSW curriculum covertly or overtly addresses each of the nine competencies, integrated into each course is a set of behaviors (practice behaviors) representing observable components of one for more competencies. Course content and assessment reflect bolded competencies and the following practice behaviors:

- 2.1.3.3 Demonstrates effective communication in working with individuals, families, groups, organizations, communities and colleagues.
- 2.1.8.1 Is skilled at analyzing, formulation, and advocating for policies that advance social well-being

- 2.1.10[b].1 collect, organize and interpret client data2.1.10[c].2 Implement prevention interventions to enhance client capacities

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Using D2L (Bright Space, using Microsoft Word, reviewing Video Lectures and PowerPoint, and using Weekly Class Discussions to learn and practice skills with peers.

Instructional Methods

The learning process will be conducted by online instruction of Weekly D2L work -- the summer course is 10 weeks long and each Week (1-10) will have the following sections the student is asked to complete for each week: Learning Objective, Video Lecture, Class Discussion, Power Point, and Review. There is also assigned reading as outlined in the calendar section (per week) at the back of the syllabus.

Student Responsibilities or Tips for Success in the Course Students will need to read the assigned chapters before starting the weekly routine. I like to suggest you login to D2L each week as early as possible and spend the week completing each task then log back in at the end of the week to discuss with your peers what you have learned from each weeks completed material. Achievement of course learning objectives will be accomplished via reading chapters, reviewing Power Points (PPts), online discussions, interview paper, and examinations. Students are encouraged to use social work life experiences in weekly discussions.

Engagement Policy

<u>Final Evaluation and Grade Depends on both Classroom attendance and Participation</u>
Inadequate participation or lack of required time commitment in each class significantly affects students' grades. No matter the course venue, students must engage in a comparable amount of time. Expectations of both Face-to-Face classes and those with Online components include time spent reading and studying course material.

To earn a level of competency within a specific course, students must demonstrate both mastery of content and active engagement.

Mastery of content areas is evidenced by successful completion of course assignments such as written papers, group project deliverables, tests/quizzes and other tangible products designed by instructors to evaluate knowledge and skills.

Additionally, the Social Work Profession is built upon human interactions and building human relationships – which is defined as engagement. Engagement is defined as meaningful involvement in interactions with instructor, peers, outside stakeholders as appropriate (such as contacting a social worker to interview for a required assignment). Within the classroom setting, whether virtual or F2F, students must actively participate in 80% of engagement activities as outlined by individual instructors. These activities can include participation in a live, synchronous virtual classes, attending a Face to Face course when appropriate, interacting with peers in posted discussions and collaborating in group interactive projects.

Students must meet standards for content mastery on tangible assignments and meet the threshold of active engagement 80% of the time during a semester.

Instructors are experts in each course content area and set the standards for students to meet for successful completion of the course.

As we enter the semester, we are all working under stresses and strains related to the COVID-19 pandemic. It is imperative we communicate consistently and frequently. If, for any reason, you are not able to complete assignments or actively engage in the course, you MUST reach out to your instructor and let him or her know.

essential that each social work student gain a thorough understanding of the ethical principles that guide practice and actively demonstrate in behavior, both in and out of the classroom.
