I. Course Description

This course is designed to help build a finance background. The course prepares students for the fundamental knowledge of business finance including time value of money, evaluating the financial performance of a firm, financial forecasting, financial instruments and markets, valuation, capital budgeting, risk/return analysis, capital asset pricing model, and cost of capital.

ACCT 222, ECO 2301, ECO 2302, MATH 1325.

III. Course Objectives

Upon the successful completion of this course, the students should be able to perform the following tasks:

1. Demonstrate an understanding of the fundamental concepts of corporate finance and its principles and methods.
2. Understand and apply valuation techniques of securities, projects and corporations.
3. Demonstrate an understanding and show ability to measure financial decisions in a risk/return environment.

Course Learning Objectives 1, 2, and 3 address COB Student Learning Objective 5: Students will be analytical problem solvers in business environments.

VI. Policies and Procedures

The class will be conducted in an online format. The purpose of the assignments is to help you review the materials learned. Some (but not all) of the problems on the exams will be similar to the problems in these assignments.

There would be **no extension** to the assignment deadline unless with official documents from a medical doctor or TAMU-Commerce official and such documents need to be provided BEFORE assignment answers are released. Documentations submitted after the answers being posted will NOT be considered. Extensions are at the discretion of the instructor. Extensions may include a late penalty.

There will be end of chapter questions & problems assigned as homework. **You do not have to submit the solutions. Solutions to these homework problems will be available in D2L.** To enhance learning, you

should devote some time to these assignments. Some (but not all) of the problems on the exams will be similar to the problems in these homework assignments.
