I. Course Description

This course is designed to help build a finance background. The course prepares students for the fundamental knowledge of business finance including time value of money, evaluating the financial performance of a firm, financial forecasting, financial instruments and markets, valuation, capital budgeting, risk/return analysis, capital asset pricing model, and cost of capital.

1. Demonstrate an understanding of the fundamental concepts of corporate finance and its principles and methods.

2. Understand and apply valuation techniques of securities, projects and corporations.

3. Demonstrate an understanding and show ability to measure financial decisions in a risk/return environment.

Documentations submitted after the answers being posted will NOT be considered. Extensions are at the discretion of the instructor. Extensions may include a late <u>penalty.</u>
