ASSESSMENT

Quizzes: 25% There will be one syllabus quiz and four chapter quizzes each worth 5% of your grade.

Exams: 30% There will be four timed exams each worth 10% of your grade. The best three exam grades of the four exams will be used and calculated in overall scores.

Discussion Board: 25% There are five discussion boards each worth 5% of your grade. Discussion board topics require a minimum of one post and two replies to fellow students. Discussions may be completed and submitted prior to the posted due date, but keep in mind that you will be graded on quality of content. Spelling, punctuation, capitalization, and grammar errors will have a negative impact on your discussion grades.

Case Study: 20% There will be two case studies each worth 10% of your grade. Students will be required to think critically about real life business issues. Please see the instructions in eCollege for more details.

NOTE: I will count off one letter grade for each day an assignment is late. Exams, quizzes, and discussions will not be opened after the due date. Extra credit work will NOT be assigned so please do not ask.
