# **COURSE INFORMATION**

## **COURSE DESCRIPTION**

An introduction to financial accounting concepts and financial reporting, with the focus being on how decision makers analyze, interpret, and use accounting information. Emphasis is given to how accounting measures, records, and reports economic activities for corporations and on the relationship between accrual and cash flow measures in interpreting accounting information. Prerequisite: Completion or concurrent enrollment in MIS 128 or CSci 126.

#### **COURSE OBJECTIVES**

Upon satisfactory completion of this course, the student will:


- 1. Apply the fundamental concepts and assumptions that underlie financial accounting principles.
- 2. Demonstrate an understanding of the steps of the accounting cycle and of the basic elements of the four financial statements.
- 3. Identify, record, and report transactions in accordance with Generally Accepted Accounting Principles.

readings will be covered in the class lectures, all the areas covered in the readings will not be part of class presentation.

#### ASSESSMENTS

Accounting is a very challenging topic and requires much practice. The weekly assignments due on the schedule below are key parts of this course and critical to your success. These assignments are to be completed on MyLab.

#### Homework

Read and outline the chapter before attempting homework. Homework assignments are worth 20 points each. The purpose of the graded homework is to practice concepts at a higher level of difficulty than the pre-class quizzes. Assignments are due by **9:00pm** on **Sunday** of that week. They have no time limit and **two** attempts. The lowest homework grade will be dropped.

#### <u>Quizzes</u>

The purpose of chapter quizzes is to give you feedback as to how much material you retained and mastered in preparation for the exams. Quizzes are worth 10 points each due every **Sunday** midnight with a duration of 30 minutes and **one** attempt. The lowest quiz grade will be dropped.

#### <u>Exams</u>

This course requires three (3) regular exams and a final exam. Regular exams are 100 points each and the final exam is worth 130 points. Regular exams are due on <u>Monday</u> <u>at midnight</u>. See the Course Calendar for a detailed breakdown of the exam dates.

Make-up exams will be considered only under extenuating circumstances. The following are considered extenuating circumstances: hospitalization, medical emergency, physical injury or death of an immediate family member. You will be **required to provide** proof of the extenuating circumstance in order to be approved for a make-up exam. Make-up exams will be scheduled within three days of approval.

#### ACADEMIC DISHONESTY POLICY FORM

#### **CPA EXAM CANDIDATES - STATE OF TEXAS**

Candidates who desire to sit for the CPA in Texas must meet the following educational criteria:

- Complete the electronic fingerprint process for a background check of the criminal history files of the Texas Department of Public Safety (DPS) and the Federal Bureau of Investigation (FBI).
- Hold a baccalaureate or higher <u>degree</u> from a board-recognized United States college or university, or an equivalent degree as determined by board rule from an institution of higher education in another country.
- Complete<u>150 semester hours</u> or quarter-hour equivalents of college credit.
- Complete 30 semester hours or quarter-hour equivalents of upper level accounting courses from a board-recognized college or university. Within the coursework two-semester hours of accounting or tax research and analysis are required.
- Complete 24 semester hours or quarter-hour equivalents of upper level related business courses. Within the coursework two-semester hours of accounting or business communications are required.
- Complete a 3-semester-hour <u>Board-approved ethics course</u>.
