2. Required Calculator: Any financial calculator is required for this course. This includes hand-held financial calculators as well as Excel and mobile apps. Note that students are held accountable on learning how to master the calculator of their choice. I will use an online calculator (also available as a mobile app) to demonstrate the working of problems (i.e., EZ Financial Calculator in Apple Apps and Financial Calculators –bishinews in Android Play Store). Calculators must manipulate irregular cash flows. A financial calculator will be advantageous to have not only when you take other business classes, but also when making personal financial decisions throughout your lifetime.

Course Description

This course introduces students to a comprehensive study of security selection and analysis techniques , security markets and how domestic and international economics affect tax structures. Prerequisites: FIN 504 or consent of instructor.
