## **Course Description**

Today, human trafficking is more commonly referred to as modern-day slavery. This global scourge is second only to drugs and gun in its net worth (see Bales & Soodalter). The tentacles of this crime spans the globe, it is as diverse, if not more so, as any other criminal enterprise. Violence, deception and money sits at the core of this crime—an understanding of these "factors" is therefore important to understanding the foothold it

has on modern societies and continues to have on a number of older, established societies. We are told in the literature that a calculated 27 million persons, globally, are "in bondage" of one form or another. This course covers the importance of "defining" human trafficking. It looks closely at such features as: sex exploitation, child abuse (sex and labor), debt slavery, domestic slavery and so much more. We also see some of the efforts of law enforcements to combat this ever evolving scourge. As a student in this course, you are invited to look at the many ways in which this *new slavery* both resembles and departs from the *"old" slavery*. The work of Kevin Bales takes center stage in this course. The course also reviews some of the ongoing efforts--successes and failures in response to human trafficking.

# **Student Learning Outcomes**

# To provide students a definition of human trafficking, including that of Homeland Security's working definition.

- 1. To provide students with a clear understanding of the vast array of crimes that fall under the label of human-trafficking.
- 2. To provide students with a global picture of human trafficking with specific focus on countries highlighted by Bales in his works.
- 3. To engage students in the discussions on how to end modern day slavery.

## Student Responsibilities or Tips for Success in the Course

*Timeliness*. Organization is key. You've likely heard it said before that it's not the "brightest" students who will necessarily be successful, but the most organized, this phrase reverberates in my mind each semester that I encounter new students; it remains one of my own key *take-a-ways* from one of my doctoral professors. This, in

itself, is a skill one must calculatedly work towards. Aim to be timely in asking questions and sharing concerns. Do not wait until the semester has ended to address issues that knowingly ca/will impact your success, as this will be too late. Be aware of due dates for all assignments (tests, discussion forums, required readings, etc.). Be sure to record these dates where you are certain to see them in a timely manner **Resources**. It is important to secure the needed tools for your class. Having access to a textbook beginning day one is encouraged. **Stay connected**. Get in the habit of checking the *announcement site/link* and your school emails regularly to stay connected. **Schedule changes**. There are times when changes to the schedule may be unavoidable, you will be informed of such via the announcement site...do not wait days to visit this site as you run the real risk of missing important notice(s)

#### Assessments

**Tests**. **Forty** (40) pts. Tests contribute 40 points to your overall grade. There are <u>two</u> tests worth a total of (40) pts. Test release days are Fridays. For your first test, you will have until Sunday, June XX, 2022 to submit. Note that once you access a test, you must complete in one sitting. Tests are individual assignments. Tests are based on assigned readings/chapters, etc., as directed by course instructor. The specific areas of focus for each test will be made known (with adjustments made, as needed), pending coverage of course material. See calendar for schedule of days and related chapters. Note that the following weeks 1, 2 and 4 are test free with tests scheduled for weeks 3 and 5. I know you'll use test free weeks to get ahead of readings as well as sourcing references for your literature review (to be discussed).

Other notes...

• **Tests are individual assignments/work**. Evidence of collusion will trigger a review and, if collusion is borne out in such investigation, this will result in a failing grade for the related assignment. Simply put, it is not worth your time to engage in such practice when you most likely would have performed perfectly well on your own. Tests are timed assessments to be completed in one

sitting, you will have only **one access**, it is therefore imperative that you take care as you open your tests. It is important to prepare before opening tests as requests to re-open a test you have already been accessed will not be facilitated. This is not a case of "punishing" anyone, but certainly a case of keeping the "playing field" level for all. Where there are questions of technical issues, your course instructor will request of the IT- department to review concerns as part of the final decision making processing before re-opening a test. You will be called upon to furnish (in writing), a detailed report of what transpired. **Contacting course faculty**. In addition, as the registered student, it is your responsibility to contact your course instructor as soon as is possible if you encounter an issue that disrupts your ability to successfully access, complete, or launch a completed assignment and one that is not attributable to student error or neglect.

- **Structure of tests**. Tests will consists of multiple choices, short answers and mini-essays.
- Practice quiz. A short practice quiz will be given before the first full test, the objective here is to "pre-test" the system before the larger assignments, thus allowing for early trouble-shooting, as needed. Your Practice quiz will be for 1 pt. You will be awarded full point irrespective of outcome, as long as you have attempted <u>all questions on the brief practice quiz</u>.

**Discussion Forum**. Ten (10) pts. Four scheduled for this class for a total of 10 pts (2.5 pts x 4 =10 pts). You must first submit a post, before you can have access to the submissions of classmates. An original post is required, this will be your most substantive post and will be for a possible 1.5 pts of the 2.5 pts for each forum. Your submission will be assessed based on relevance, content, and clarity. Postings should reflect **your voice** on the topic of discussion, along with aptly weaved in citations from relevant literature. APA applies. Note that the discussion is not, however, a literature review. Remaining point will be based on your response and engagement to at least two classmates' original posts; these must make a point-simply stating that you "agree with" or "like" and similar version that would be assessed as simply that will not be sufficient to move the mark on grading; aim to engage your classmates. Stacking. Time is also a factor in grading; if all your postings are submitted in close time, this does not give your reader adequate time to digest and respond—it does not mirror the intended "classroom" discussion and will ultimately impact the final grade. The recommendation is that you review the topic, prepare your first (more substantive post) and submit. Take time to read the works of others, decided which you'll respond to and submit with care for spacing these engagements. Remember-a total of three postings required. You can submit more than three responses to the forum.

**Reflection Papers**. Fifteen(15) pts total. Three required. These will be based on either a review of a written article, chapter, video footage or movies and asked to prepare a brief reflection on what you viewed. Two typed written pages required (double spaced).

Project Paper. Forty (35) pts. An individual project is required. The final paper should be no more than 10 type written pages (APA applicable...12 pt. font, double spaced, bibliography, etc.). Six-to-seven pages will be relevant *literature review*. You will need a research question or statement of interest of problem, you will propose a research methodology with rationale to employ were you going to complete this research. Last, a short statement on anticipate results. SPECIAL NOTE: YOU WILL NOT BE CONDUCTING RESEARCH, just proposing what that would look like if you did. NOTE: More discussions to come on this project.
