Course Description

BSC 1407: Introductory Biology II **AND**
CHEM 1311 General and Quantitative Chemistry I

An introduction to molecular genetics including Mendelian and population genetics, replication, transcription, and translation. Gene expression and regulation. Use of current genomic methodologies including genotyping and transgenics in animal agriculture.

1. Explain and define genetics terms and concepts presented in lecture.
2. Describe chromosomal structure and the biochemical structure of DNA and RNA
3. Describe and explain the processes of replication, transcription, and translation.
4. Explain in writing the stages of mitosis and meiosis and contrast differences in each
5. Describe Mendelian inheritance, the components of the genetic model, and difference between qualitative and quantitative traits.
6. Calculate population gene and genotypic frequencies.
7. Explain the significance of dominance and the difference between complete, incomplete, codominance and epistasis.
8. List the types of gene mutations and explain advantages and disadvantages of gene mutations
9. Describe the different genetic markers including microsatellite, single-nucleotide polymorphisms and their role in livestock production.
10. Describe how animals are genetically modified and their uses today in livestock production.
11. Explain the lab assays and procedures used in genetics including PCR, sequencing, microarrays, whole-genome sequencing
