Course Description and Student Learning Outcomes:

The Honors colloquium provides honors students the opportunity to listen to speakers discuss timely local, regional, and world issues. The overall goals are to provide opportunities to be motivated by others' enthusiasm for their field, to be exposed to new ideas, and to share time with other intellectually curious individuals.

COURSE REQUIREMENTS

Instructional Methods, Activities, and Assessments

A. Attendance

There is no attendance requirement in the traditional sense as we will not be meeting for class. Your task is to locate 8 speakers, attend those speaking events, and provide evidence of attendance at those events (e.g., photo of program, selfie at the event, etc.). You can attend some of the events virtually, but they must be lived – no recorded events (e.g., TedX Talks) as the hope is you'll have the opportunity to hear audience reactions and potentially interact with other attendees. I will put some links in the D2L portal for these events, but please don't view that as a complete list of opportunities. If in doubt about whether an event 'counts,' just reach out to me.

B. Reaction Papers:

To gain credit for HC 400, students are required to write reaction papers on three presentations. A proper reaction paper will contain an intellectual reflection on what took place during the talk that you attended. That reflection in writing should go beyond being merely a series of notes you take and write up.

The paper may cover some of the following points:

- What was said that you agreed with?
- > Or disagreed with?
- ➤ Can you connect an aspect of what you learned from the colloquium session to another event you have read about or heard about or observed or even experienced in your own life?
- ➤ What interested you the most?
- ➤ Least?
- ➤ What would you have done or said differently?

Obviously, you do not have to answer all of the above questions. Nor do you have to respond to any one of them. What your paper should show is your mind at work—much like a book critic or movie critic does when she or he writes a review. Length? I'd say two typed, double-spaced pages (around 500 words).

C. Letter to Freshman Assignment

Each colloquium speaker will highlight their own individual expertise and often draw upon life lessons that may be applicable to your own experiences. As you near the end of your college career, you have grown and developed an acumen for success. Pen a letter to an incoming freshman in the class of 2022. What lessons have you learned during your time in the Honors College? at TAMU-C? in life? What advice would you give a brand new college freshman so they can maximize their college experience?

D. Grading Scale
