Course Description

This course will explore the social and cultural construction of gender differences, focusing on contemporary issues both in the United States and internationally. This course will provide an in-depth focus on sexuality and gender, examining gender socialization, gender and sexual minorities, and gender differences in social institutions.

1. Take a sociological perspective on gender and sexuality
2. Better appreciate and understand the condition of gender inequality in the United States
3. Critically analyze common sense understandings of gender
4. Effectively synthesize course materials and apply facts and theory to construct arguments

- *Photo Essay*- For your final assignment, worth 50 points, you will produce a photo essay to tell a visual story about something you learned in class. The goal is for you to illustrate an idea or concept from class in a creative way. A rubric for the final project can be found on D2L.
