Course Description

The purpose of this course is to explore current training and development policy and practices in today's organizations. The focus will be on work engagement, an increasing area of interest that has implications for learning culture, performance, work/life balance issues, and a host of related topics. The course will be taught to develop integrative literature review based on online discussion.

Student Learning Outcomes

- 1. Define work engagement and explain related terms, concepts, and issues
- 2. Discuss current research on work engagement
- 3. Synthesize research and apply to training and development policy and practices

Course Grade

Weekly discussion (6 at 100 points each): Online discussions will serve as a comprehension check on selected topics.

Reflection paper/Article abstract (1 at 100 points each): Each student will prepare a reflection paper of an abstract of a research article that is related to the focus of this class.

Organization analysis (800 points): The purpose of this assignment is to provide you with the opportunity to conduct an in-depth investigation of an organization and apply the knowledge learned in this course.

- You will need regular access to a computer with a broadband Internet connection. The minimum computer requirements are:
 - o 512 MB of RAM, 1 GB or more preferred

- You must have a:
 - o Sound card, which is usually integrated into your desktop or laptop computer
 - o Speakers or headphones.
 - *For courses utilizing video-conferencing tools and/or an online proctoring solution, a webcam and microphone are required.
- Both versions of Java (32 bit and 64 bit) must be installed and up to date on your machine. At a minimum Java 7, update 51, is required to support the learning management system. The most current version of Java can be downloaded at: java.com/en/download/manual.jsp
- Current anti-virus software must be installed and kept up to date.

Running the browser check will ensure your internet browser is supported.

Pop-ups are allowed.

JavaScript is enabled.

Cookies are enabled.

- You will need some additional free software (plug-ins) for enhanced web browsing. Ensure that you download the free versions of the following software:

- At a minimum, you must have Microsoft Office 2013, 2010, 2007 or Open Office. Microsoft Office is the standard office productivity software utilized by faculty, students, and staff. Microsoft Word is the standard word processing software, Microsoft Excel is the standard spreadsheet software, and Microsoft PowerPoint is the standard presentation software. Copying and pasting, along with attaching/uploading documents for assignment submission, will also be required. If you do not have Microsoft Office, you can check with the bookstore to see if they have any student copies.
