ORGANIZATION LEADERSHIP PROGRAM DESCRIPTION

The Bachelor of Applied Arts and Sciences in Organizational Leadership (ORGL) degree is a competency-based program that prepares innovative leaders for employment in an increasingly technological and global society. This program provides opportunities for students to receive credit for what they know and can do already, allows them to accelerate completion of their degree, and — because it is fully online — students are able to plan their study schedule around the rest of their day to complete the coursework.

COURSE DESCRIPTION

This course focuses on the principles and practice of management in an organizational setting. The course is designed to provide students with the knowledge and skills that can be used to analyze organizational processes and address challenges inherent in managing organizations, operations, and projects. Management theory is applied to practical problems in planning, organizing, leading, and controlling workplace situations and business activities. Prerequisites: ORGL 4341 with a minimum grade of B.

STUDENT LEARNING OUTCOMES

Completion of this course provides the student with the knowledge to:

1. Recognize, analyze, and articulate theories and concepts related to the leadership function of management at all levels of an organization.
2. Appraise the activities necessary for controlling functions at all levels of an organization.
3. Identify project management processes including initiating, planning, executing,
4. monitoring and controlling, and closing the project.

5. Explain the purposes of project scope, project time, project cost, project quality, project resources, project communications, and project risk.
6. Demonstrate leadership and project management skills in developing an implementation plan for a process improvement.

REGULAR AND SUBSTANTIVE COURSE INTERACTION

As a general guide, students enrolled in a three semester hour course should spend one hour engaged in instructional activities and two to three hours on out-of-class work per week in a traditional semester. Students are expected to double this effort of engagement given that this course is being delivered in a seven-week term. Educational activities in this course are designed to ensure regular and substantive interaction between students and faculty to ensure that students are able to demonstrate competency.

UNIVERSITY GOALS

This course supports the following university goals:

1. Critical Thinking Skills (CT): to include creative thinking, innovation, inquiry, and analysis, evaluation, and synthesis of information;
2. Communication Skills (C): to include effective development, interpretation, and expression of ideas through written, oral, and visual communication;
3. Empirical and Quantitative Skills (EQ): to include the manipulation and analysis of numerical data or observable facts resulting in informed conclusions;
4. Teamwork (T): to include the ability to consider different points of view and to work effectively with others to support a shared purpose or goal;
5. Personal Responsibility (PR): to include the ability to connect choices, actions, and consequences to ethical decision-making; and
6. Social Responsibility (SR): to include intercultural competence, knowledge of civic responsibility, and ability to engage effectively in regional, nation, and global communities.

ASSESSMENTS/COURSE ASSIGNMENTS

Required Course Pre-test

The purpose of the pre-test is to provide a baseline understanding of your knowledge in this competency. The pre-test is required before you begin studying course materials. If you do not make at least 80% on the pre-test, students will be expected to complete assignments, quizzes, and other course content to prepare for the post-test and culminating project.

Pretests are taken once and should be completed upon the first couple of days of a CBE academic term or entry into a course if a student is an accelerator.	100 points	Required before completing any other work in the course. Required Course Post-test

The end-of-course comprehensive exam that assesses student knowledge and understanding of major concepts, theories, processes, etc., in the course. A **score of 80% or higher is required** to demonstrate competency.

Students who fail the posttest should review feedback from the instructor before reattempting the posttest.</p>

Required Culminating Project

The project assesses your knowledge of terms and the application of concepts presented in this course. A **score of 80% or higher is required** to demonstrate competency.

			If students score less than 80% on the culminating project, they will have an opportunity to review the material and resubmit the project up to two additional times. If the culminating project is less than 80% within three attempts, students will receive a grade of "F" in the course and will be required to retake the course in the new term.

4 Optional Discussion Questions

A brief short-answer item that the student submits to the instructor that requires students to synthesize and apply the concept, theory, process, etc., is introduced in the Learning Objective Module. Discussion posts are submitted to the instructor and do not require comments or "discussion" with other students in the course. Completion of the 4 discussion posts is optional. If you complete the discussion post, you will receive a score, but it is **not** reflected in your final grade.

4 Optional Quizzes

A brief quiz at the end of each module that is intended to emphasize key concepts, theories, processes, etc., is introduced in the Learning Objective Module. Completion of the 4 quizzes is optional. If you complete the quiz, you will receive a score, but it is **not** reflected in your final grade. Completing the weekly quizzes are important to help you understand what is on the post-test.

GRADING

A score of 80% or higher on both the Culminating Project and Posttest is required to demonstrate competency and receive credit for the course. The following items will be used to calculate the final grade in the course.
