Course Description:

This course includes a study of the nature and psychology of stress with particular emphasis placed on coping strategies and relaxation techniques. Conflict resolution and interpersonal relationships will also be discussed.

Course Objectives:

By the end of the course, the successful student should be able to:

1. Understand the nature of stress.
2. Know and describe the aspects of holistic stress management.
3. Complete worksheets related to the body, the emotions, the mind, and the spirit and stress.
4. Participate in activities related to effectively coping with stress.
5. Participate in activities related to effective relaxation.
6. Design a personal relaxation program.
