- 2. Discuss issues with classmates. A course about controversial issues would not be complete without some serious conversation with peers.
- 3. Position Statement. You will summarize your learning about the controversies, discuss the positions you now hold, how those position have been influenced through the course,and your action plan for influencing peers and leadership. This position statement may be made delivered via one of three possible venues: a written composition, Power Point slide presentation, or video presentation of some sort.
