## **Course Description:**

This course provides a study of the educational implications of educational theory and other philosophical schools of thought. The course will stress the applications of these philosophies to the practice and implementation of curriculum, instruction, and student learning. Study of philosophical theories will assist in understanding the source of many popular opinions and perceptions regarding education including: the anxiety that education is adrift, the concern that educational aims are vague or conflicting, uncertainty about the role of education in a democratic society, and concerns regarding the relationship between theory and practice.

## **Student Learning Outcomes:**

1. Discuss the historical context and leading philosophers of the schools of thought.
2. Discuss each of the theories/philosophies as they relate to the aims of education, teaching methods, curriculum, educational policy, and learning.
3. Develop and identify a personal teaching philosophy.
4. Explore contemporary philosophers' ideas and the applications of those ideas to secondary schools.

## **COURSE REQUIREMENTS**

The following requirements will constitute the grade for this course. More specific details about each assignment will be included on ECollege.

1. Personal, disciplinary philosophy exploratory essay – 10%
2. Educational philosopher analysis essay – 20%
3. Educational policy/ contemporary issue and philosophy project – 20%
4. Weekly chats, philosophical reflections, discussion board postings – 50%  
(8 readings/ chats/ postings worth 6.25% each)

Total = 100%

Final grades in this course will be based on the following scale:

B = 80%-89%

C = 70%-79%

D = 60%-69%

F = 59% or Below

## Assessments

Learning in an online environment necessitates regular (daily) involvement in class materials and activities. Each week, students will need to view the online lectures, post comments on the discussion boards, complete the assigned readings (with accompanying journals), and participate in the chats. Attending the chats is *strongly* encouraged; however, the chats will be archived for later viewing. Students electing not to attend the chats are still responsible for viewing the material and completing the alternate assignment by the deadline.
