Course Description

This course will investigate the overview of the major adult learning theories linked to the practice of adult education in various adult learning contexts. Students can examine which theoretical foundations best fit their perspective on adult learning and are expected to establish their own principles on adult learning.

Student Learning Outcomes

1. Discuss the contexts that drive continuous learning in adulthood

2. Apply the learning theories and skills to adult education contexts (We will explore the traditional learning theories, andragogy, self-directed learning, transformative learning, experiential learning)
3. Develop, describe, and defend personal adult learning principles

COURSE REQUIREMENTS

Minimal Technical Skills Needed

This is a fully online course. Assignments will be delivered via a Learning/Course Management System. Knowledge of the substantive material covered in the course is of central importance. Grading will include consideration of content as well as grammar, spelling, organization, and explicit use of readings. A serious commitment to mastery of the content and contribution to everyone's learning is expected. An online course inherently requires students to be active, reflective, and contributive learners.

Assigned readings are noted within the module overview as well as on the course schedule. Required module readings will serve as a basis for online discussion. Late submissions, one week past the due date **WILL NOT** be accepted, and each day late will incur 10% score deduction. I do understand that sometimes there are circumstances outside one's control that may impact timely submission of assignments, such as jury duty, hospitalization, or death of a family member. In these instances, a student is expected to notify the instructor **BEFORE** the assignment deadline.

Course Grade

Discussion Boards (4 at 100 points each = 400 points total): Each discussion thread topic will require a "post" and two "replies" to fellow classmate's posts.

Weekly Reflection (4 at 100 points each = 400 points total): Each student is to post a journal entry for each module's reading assignment.

Teaching Philosophy (800 points): The teaching philosophy paper is a personal statement that introduces you as an educator while expressing your values and beliefs about teaching. The teaching philosophy paper is intended to be an opportunity for you to focus your thoughts to advance your perspective as a Master degree level training expert. Use it to develop your own understanding and meaning of the adult learning theories and perspectives addressed in this class. You need to submit ten pages expressing your teaching philosophy based on your reflection in which you analyze and question new ideas in the context of your own experiences as an educator (or as a learner). You choose one (or more) theories/perspectives (i.e. andragogy, self-directed learning, transformative learning, experiential learning, situated learning/community of practice, critical perspectives) that will be discussed in class. For an in-depth teaching philosophy, you could use literature that goes beyond the class readings.
