HEALTH SERVICES ADMINISTRATION PROGRAM DESCRIPTION

The Bachelor of Applied Arts and Sciences in Health Services Administration (HSCB) degree is a competency-based program that prepares innovative leaders for employment in an increasingly technological and global society. This program provides opportunities for students to receive credit for what they know and can do already, allows them to accelerate completion of their degree, and — because it is fully online — students are able to plan their study schedule around the rest of their day to complete the coursework.

COURSE DESCRIPTION

This course is designed to demonstrate a student's mastery of the discipline and ability to apply knowledge acquired throughout the program to solve a real-world problem related to their future health-related career interest.

STUDENT LEARNING OUTCOMES

Completion of this course provides the student with the knowledge to:

- 1. Analyze new healthcare regulations/laws to determine the impact on different stakeholders, including care delivery organizations, payers, and individuals
- 2. Analyze the impact of changes to payment mechanisms on healthcare delivery and health outcomes using economic and insurance concepts
- 3. Distinguish and compare the major settings for, and types of, healthcare services, including individual and population health, and payers
- 4. Demonstrate effective verbal communication
- 5. Prepare effective written business communications
- 6. Value the roles and relationships of governance, executive leadership, and external stakeholders in strategically addressing the health needs of a community or target population.

REGULAR AND SUBSTANTIVE COURSE INTERACTION

As a general guide, students enrolled in a three semester hour course should spend one hour engaged in instructional activities and two to three hours on out-of-class work per week in a traditional semester. Students are expected to double this effort of engagement given that this course is being delivered in a seven-week term. Educational activities in this course are designed to ensure regular and substantive interaction between students and faculty to ensure that students are able to demonstrate competency.

COURSE REQUIREMENTS

Minimal Technical Skills Needed: Students will need reliable computer and internet access for this course. Students must be able to effectively use myLeo email, myLeo Online D2L, and Microsoft Office.

ASSESSMENT

Students must achieve 80% or higher for the module assignments and culminating project to demonstrate competency and pass the course.

Learning Objective Assignments

Assignment that the student submits to the instructor that requires students to synthesize and apply the concept, theory, process, etc., introduced in the Learning Objective Module. Essays are submitted to the instructor and do not require comments or "discussion" with other students in the course.

Culminating Project

The project assesses your knowledge of terms and the application of concepts presented in this course. A **score of 80% or higher is required** to demonstrate competency.

If students score less than 80% on the culminating project, they will have an opportunity to review the material and resubmit the project up to two additional times. If the culminating project is less than 80% within three attempts, students will receive a grade of "F" in the course and will be required to retake the course in the new term.

GRADING

A score of 80% or higher on both the Culminating Project and Posttest is required to demonstrate competency and receive credit for the course. The following items will be used to calculate the final grade in the course.
