Focuses on critical knowledge and skills necessary to carry out organizational goals and objectives.

Spelling, punctuation, capitalization, and grammar errors will have a negative impact on your discussion grades.

Syllabus and Calendar Quiz: 5% Students will be required to take one quiz covering material found in the syllabus, calendar, and grading rubrics.

NOTE: I will count off one letter grade for each day an assignment is late. Exams, quizzes, and discussions will not be opened after the due date. Extra credit work will NOT be assigned so please do not ask.
