## **Course Description**

This course provides an overview of the history of theatre with emphasis on how theatre has changed over time. It is designed as an introductory course to all aspects of theatrical productions with an emphasis on active participation.

## **Student Learning Outcomes**

- 1. Students will learn basic theatrical history and vocabulary while surveying the purposes of theatre.
- 2. Students will discuss, analyze, and practice the production process. They will learn the different roles of theatre practitioners, the importance of collaboration, and how theatrical performances are created.

3. Students will develop an appreciation for theatre and gain an understanding of the direct influence it has on society.
