# FDSC 1329-Principles of Food Science Syllabus-This is an online course

## **Course Description:**

This course will introduce students to the concepts of food science and systems at the local, regional, and global levels. Students will examine and reflect upon critical issues that influence food systems such as nutrition, food production and processing, safety and labeling, distribution and marketing, and more.

#### Text:

There is no textbook for this course. However, there are many online resources in print format (mostly PDF) that students are expected to retrieve and read prior to the related online discussions or assignments. Saving and/or printing these documents are advised.

## Student Learning Outcomes:

- 1. Students will become familiar with food science, safety, processing, nutrition, labeling, etc. through online discussions, assignments, multimedia links, labs and experiential activities.
- 2. Students will be able to clearly communicate their understanding of relevant food science concepts with others.
- 3. Students will be able to analyze, evaluate, and problem solve circumstances involving food science through assignments and activities.
- 4. Students will take a role in their own education regarding food science by following the online design/activities of this course.

This course is divided into 15 modules of instruction outlined for completion of one module per week in D2L, the university's online course management system. Each module will have an overview and hyperlinks to print and media resources for review and two discussion questions oriented to these resources. Additionally, there are seven written assignments designed for the student to demonstrate understanding and ability to synthesize the information presented as well as apply course concepts to various projects. Details and directions for these assignments will be presented in D2L.
