Assessments

Quizzes (50 points) will be due every week starting with **Week 1**. Each quiz is worth 5 points and students will have their two lowest grades dropped at the end of the course. The plagiarism quiz cannot be one of the two quizzes dropped. All quizzes are open book and open note.

Essays (200) will be due in lieu of midterm and final exams. These essays should cover a topic addressed in the text up to that point and be in the form of a literature review. Each essay should be a minimum of five pages and a maximum of 10 pages. Additionally, it should be written in APA 7th edition format and include at least three peer-reviewed sources.

Extra Credit (up to 10 points). Extra credit will be given to those who participate in research studies via SONA. If you're unable to complete a study or simply do not wish to, contact the instructor for other extra credit options (e.g., one page paper, extra Article Summary, etc.).
