

**Course Description:** This course introduces students to the common principles and practices associated with sustainable agriculture from ecological, economic, social, and ethical perspectives.

### **Student Learning Outcomes:**

Upon completion of the course the student will be able to-

- a. **Learning Outcome 1:** Students will be able to demonstrate *knowledge* of the interdependence of global dynamics in our present food system as well as the need for more sustainable alternatives.
- b. **Learning Outcome 2:** Students will be able to *apply* knowledge of the principles of sustainable to the context of food production as evidenced through course related activities and assignments.
- c. **Learning Outcome 3:** Students will be able to view themselves as *engaged* citizens within the context of sustainable food production and its relevance to people, profits, and planet.

The following instructional objectives will guide course content to achieve these outcomes.

1. Recognize historical and contemporary issues of in agriculture and food systems in context of resource utilization and conservation.
2. Identify, analyze, and utilize various sources/types of information and:
  - a. Discuss *case studies* and examples of sustainable food production,
  - b. Distinguish between conventional and sustainable agriculture,
  - c. Determine relevant sources of training and professional development.
  - d. Recognize agencies and organizations supporting sustainable agriculture.
3. Evaluate the advantages and disadvantages of specific farming methods.
4. Present contrasting and/or informative viewpoints in a civil and effective manner.
5. Compose informative and persuasive essays on relevant topics.
6. Develop and deliver an informative presentations.
7. Examine ecological, economic, and social impacts of farming methods.
8. Identify sources of influence in the development of regulations and policies affecting the production, distribution, and management of food, agriculture, and natural resources systems.

### **Class Attendance and Participation in Discussions**

Students are expected to discuss experiences and observations, as well as ask questions. Being in attendance is only part of the learning process. By discussing issues and asking questions, you will reinforce learning through a multi-sensory approach. ### **Introductory Video**

Student will prepare and submit a 30-45 second video introducing themselves to our Facebook course page.

### **Video Farm/Case Study Report**

Each student will identify a farm (or case study from USDA) that utilizes sustainable practices. The student may read reviews webpages, Facebook page and conduct interviews to develop a 2-3 minute video presentation about the farm/case. The video presentation will be shared, when due, on the course Facebook page.

### **Research Brief**

Students will select and read a research article related to some aspect of sustainable agriculture and summarize key points in 2-3 paragraphs. In the final paragraph, the student will describe how this research relates to one or more topics presented/discussed in class and whether or not the research could be put into practice in Northeast Texas.

### **Poster Presentations**

Each student will create a *poster presentation* elaborating on a sustainable agricultural practice or equipment item, if used makes farming more sustainable. Presentations will be submitted in D2L and may posted to Facebook for peer/instructor/guest review at a date and time TBA.

### **Final Exam or Essay (in lieu of final exam)**

Each student will compose an essay that synthesizes the key elements of issues and practices discussed, facts presented, and opinions shared during the course. The professor will provide 3-4 prompts from which the student will respond to one. At the professor's discretion, he may choose to use a traditional objective final exam.

### **Written Assignments and Format**

The Research Brief, presentation, and essays should be written in a format compatible with the *American Psychological Association (APA) Manual for Publication*, 7<sup>th</sup> edition. A synopsis and tutorial on scientific writing, including the use of APA format is available from the Online Writing Lab at Purdue University (<http://owl.english.purdue.edu/>). Personal face-to-face assistance with editing and format suggestions is available from the on-campus Writing Center at TAMU-Commerce.
