Course Description

This competency-based course considers what the future of policing in the United States looks like from a police leadership perspective, emphasizing the context that includes the evolution of American policing; drivers of change in police institutions; police organizational dynamics; and specific issues widely accepted as having the potential to greatly impact police organizations of the future.

Student Learning Outcomes

1. Students will be able to explain the historical development of American policing.
2. Students will be able to articulate the drivers of change in American policing and speak to what shifts may occur in law enforcement as a result of those changes.
3. Students will be able to identify the ways that police leaders should prepare for the future of law enforcement.

4. Students will be able to think critically about the ways that police organizations will adapt to drivers of change and future events.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students will need a reliable computer and internet access for this course. Specific capabilities of the computer are discussed later in the syllabus. Students are required to demonstrate proficiency in myLeo navigation in order to participate in this course. Fluency in programs like Microsoft Word, PowerPoint, and Excel may further contribute to student success in this course.

Instructional Methods

This course is 100% online. As such, communication and assignment submissions are all done electronically. Power points, resources, assignments, and tests are all located within the online course.

Student Responsibilities or Tips for Success in the Course

Students are encouraged to thoroughly read all assignments and view relevant videos as directed. Critical thinking exercises will help students with the practical application of the concepts presented, and students are encouraged to read through them after completing each module. Students are encouraged to e-mail the professor as they encounter concepts that after reading and utilizing course resources (supplemental documents, Youtube videos, etc.), still do not understand.

GRADING

Final grades in this course will be based on the following scale:

*Students are required to achieve 80% or higher on a post-test in each competency and on the project in order to pass the course.

Assessments

Pretest and Post-test for Each Module

The purpose of the pretests is to provide a baseline understanding of your knowledge in each module. The Post-test is an assessment of your knowledge of the material required for the module. If you score less than 80% you will have an opportunity to review the material and re-take the module Post-test. You will have up to three attempts at passing each competency. If you have not passed the module in three attempts, you will receive a letter grade of an F. In order to demonstrate competency, a score of 80% or higher is required.

Project

You will also have a project in this course. The project will be based on expanding your knowledge and applying the information you have learned in a practical exercise. A score of 80% or higher is required.

Final Grade Calculation

The final grade will be assigned by taking the average of the post-test and the grade of the project.

A grade of 80% or higher is required on a posttest. You have 3 attempts to achieve a grade of 80% or higher. Aside from the tests, there is one required course project that each student is required to participate in and an 80% or higher is required.
