Course Description:

A broad interdisciplinary course in the historical development of the United States and North America from 1865. Note: Assignments will focus on reading, writing, and analysis. Pre/co-requisite Eng. 1301or 1302.

Student Learning Outcomes (Should be measurable; observable; use action verbs)

- 1. Critical Thinking Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.
- 2. Communication In written, oral, and/or visual communication, A&M-Commerce students will communicate in a manner appropriate to the audience and occasion, with an evident message and organizational structure
- 3. Personal Responsibility Students will understand and practice academic honesty.
- 4. Social Responsibility Students will demonstrate an understanding of societal and/or civic issues.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students must possess the skills necessary to update and utilize reliable computer and internet access. Access to an alternate location (TAMUC Waters Library, local public library, etc) in the event of technical difficulties. It is recommended that students acquire a local library card now so you are prepared for the semester if you are a remote student and do not have access to Waters Library. Students need to be familiar with Microsoft Office and navigating Brightspace.

The course will provide an overview of U.S. History from 1865 to the 21st century. Students will receive 10 primary source Documents, 2 exams, and a research paper that will assess their knowledge on the topics discussed throughout the course.

Assessments

Document Analysis: Students will be assigned 5 primary source documents from the American YAWP textbook. Each student will read the document and answer these five questions pertaining to each document.

- 1. Background: What period and Where?
- 2. Author & Audience: Who wrote it? Who were they writing to?
- 3. Purpose: Why did they write the document?
- 4. Response: What happened following this document? Was something done?
- 5. Importance: What makes this document important in History?

The student must answer the questions on Microsoft Word and submit the file to D2L. Each document is worth 20 points.

Student Learning Outcomes: 1, 2, & 3

Research Paper and Proposal: Students will write a research paper covering any historical figure based on the sections discussed throughout the course. Students must get approval from the instructor before starting research. The paper will be 4-6 pages long not including the bibliography and must consist of at least five academic sources. Prior to the paper, students will send a proposal, which includes an introduction paragraph outlining your figure and 3 bibliographic citations. Students will need to cite their sources in Chicago/Turabian style, which consist of footnotes and a bibliography at the end of the paper. Students will receive a rubric on D2L that will outline further instructions on the structure of the paper. For the research paper, there are no late submissions. Students must turn in paper by the due date or not receive a grade.

Student Learning Outcomes: 1, 2, 3, & 4

Exams: Student will take two exams for this course. Each exam will cover all the material discussed in the lectures and through the American YAWP Textbook. Each exam will consist of essay questions that the students must answer in full depth. Student must look over the material; demonstrate their knowledge, and understanding of the course material. There is a Make-up exam for the first exam only if the student fails to show up on the day of the exam. The student must meet with the instructor in order to setup a date.
