COURSE DESCRIPTION

The purpose of this course is to study the underlying ideas, principles, and participatory practices of constitutional government in the United States. This course will introduce you to the formation of the federal constitution, and the challenges and opportunities granted by federalism and representative government in the United States. We will also analyze civil liberties and civil rights and the roles that public opinion and the media play in U.S. politics.

CLASSROOM RULES

- **Unless we assign a day to use technology as part of the learning process, use of personal electronic devices (cell phones, laptops, ipads, ipods, smartwatches, mp3 players, etc.) in class at ANY TIME is STRICTLY forbidden. Use of electronic devices during class time will result in a POP QUIZ for the ENTIRE class.**
- **Except for group activities, speaking with people around you is STRICTLY forbidden.**
- **Coming to class late is NOT allowed. The classroom door will NOT be opened for late arrivals 10 MINUTES after class starts.**
- **You are NOT allowed to get up and leave the classroom in the middle of the class unless absolutely necessary.**
- **If you disrupt class or violate any of the classroom rules, you may be directed to leave the classroom IMMEDIATELY.**

FORMAT OF THE COURSE

The class will be a mix of lectures, debates, and group activities. An outline of the reading schedule is provided in this syllabus. Students are required to come to class prepared to discuss the assigned materials. In addition to the assigned readings, we may also discuss current political events since developments in U.S. politics occur daily.

STUDENT LEARNING OUTCOMES

- Explain the origin and development of constitutional democracy in the United States.
- Demonstrate knowledge of the federal system.
- Describe separation of powers and checks and balances in both theory and practice.
- Demonstrate knowledge of the legislative, executive, and judicial branches of the federal government.
- Evaluate the role of public opinion, interest groups, and political parties in the political system.
- Analyze the election process.
- Describe the rights and responsibilities of citizens. Analyze issues and policies in U.S. politics.

COURSE REQUIREMENTS

Attendance & Participation: Attendance will be taken regularly. If you're found absent more than 3 times without an excuse, your final grade will automatically drop by "5 points" (e.g., if you earned 82 out of 100 in the end of the semester, your final grade will drop to 77). In-class activities are part of your final grade and will be offered in class randomly throughout the semester. Sleeping in class, side-talk with your neighbors, coming to class late, use of personal electronic devices and any other class disruptions (refer back to classroom rules please) will result in significant deduction of points from your attendance/participation grade.

Exams: There will be two midterms and a final exam. Both the midterms and the final will consist of multiple-choice questions. Final exam will take place during finals week and will be cumulative. Study guides will be available. Exam dates can be found on the course schedule.

Debates: Throughout the semester, we will have two in-class debates based on topics related to U.S. domestic and foreign policy. Debate topics will be posted on D2L at least two weeks before the debate date. Everyone will receive a performance grade for each debate based on participation. This will require a) being present in class during the debate; b) participate in the discussion with thoughtful comments. If you miss the class on a debate day, your performance grade will automatically be "0". Debate dates can be found on the course schedule.

Group Research Project: To complete this assignment, students will work in groups and identify a problem/issue related to U.S. politics and analyze it from the perspective of the Democratic and the Republican Party principles. A detailed guidelines and grading rubric for this assignment can be found on D2L. Research papers are expected to be 5-7 pages in length. Students will do preliminary presentations in class on **October 17** to get feedback on their topic. Final papers are due **December 11, 11.59 pm**.
