Course Description:

This course is a survey of the principles and practice of the political system in Texas. In addition to examining the state constitution and the institutions that it empowers, a wider look is taken to consider local governments, the political system, and the actors in the political system.

Format:

Lectures and discussions: Each class session will feature PowerPoint lectures and a discussion of current events in Texas politics. Note: You will **NOT** be told what to think in this course. Rather, you will be provided with the tools to make your own assessments about political issues.

Your **attendance and participation** in class lectures/discussions are very highly recommended and desirable, but ultimately, this is up to you. Attendance will be taken during each class session for record-keeping; however, it will not count toward your grade. These lectures/discussions will NOT be recorded nor streaming online. Likewise, PowerPoint slides will only be visible to those who attend class. *The only circumstances in which you must inform me of the reason for your absence is if you miss an exam, and/or if you will be absent for an extended period of time.*

ALL EXAMS will take place in-person in the classroom, however, a few specific assignments must be completed and/or submitted online. Please be aware that if you choose to attend class lectures and discussions, you **MUST** adhere to ALL of the following rules:

1. **Electronic devices** (such as cell phones, laptops, ipads, earbuds, smartwatches, etc.) of any kind are **NEVER** permitted during class. You will be directed to stop using these items and/or leave the classroom immediately if you have an electronic device visible.

2. **Disruptions of any kind** (as determined by your professor, such as side-conversations and ANY display of disrespect to anyone) are absolutely prohibited in a university classroom. You will be directed to cease this type of activity and/or leave the classroom immediately if you disrupt class in any way. Persistent disruptions will be reported to the Dean of Students office for further action and you will be prohibited from attending class until the Dean of Students has authorized your return.

3. **Be on time.** The class door will be closed and locked 5 minutes after class begins, and will not be opened for anyone until class is dismissed. If you know you will be arriving late or need to leave class early for any reason, you must inform your professor before class begins.

4. **Follow the Code of Student Conduct:** All students enrolled at the university shall follow the tenets of common decency and acceptable behavior conducive to a positive learning environment. Faculty have the authority to direct students who exhibit inappropriate behavior to leave the classroom and may refer serious offenses to the University Police Department and/or the Dean of Students for disciplinary action. INSTRUCTIONAL METHODS

This course is divided into FOUR units. There will be four examinations, one for each unit. A short writing assignment will be required during Finals Week. Note: There is not a comprehensive final exam in this course.

COURSE REQUIREMENTS & ASSIGNMENTS

Your grade will be comprised of:

- A) Four in-person Examinations (worth 23% each, 92% total),**
- B) One in-person Quiz (worth 4%)**
- C) One Writing Assignment (4%) during Finals Week, and**
- D) Your submitted Student Statement of Personal Responsibility (1% Extra Credit-- IF submitted to me by the deadline).**

Each element of your grade is described below.

A) Examinations: In this course, **all students are required to take FOUR IN-PERSON exams**, each of which will consist of 30 questions in a multiple-choice format. **You MUST bring a GREEN OR BROWN SCANTRON AND A #2 PENCIL** to the classroom on exam days and will have the entire class period to complete each exam. Together, these exams will comprise **92%** of your grade (each exam is worth 23%). The exams are NOT comprehensive. There is NOT a final exam in this course, but you will have to complete a writing assignment during Finals Week.

If you do not complete an exam during the designated class session, you will receive 0% for that exam.

If you have a **legitimate reason** for not completing an exam during the designated class session (e.g. severe illness or injury *requiring professional medical care*, emergencies in your *immediate* family, participation in *official* university activities, legal obligations) **AND** you have **supporting documentation** for your inability to take the exam, then you may **request** taking a make-up exam that will take place during the professor's office hours. Requests for make-up exams **MUST** be made either in advance of the exam date (for example, if missing class to participate in a university activity) OR within 72 hours of missing an exam if the absence was caused by a legitimate unexpected reason.

****NOTE: Forgetting to take an exam is NOT a legitimate reason for missing an exam and you will not be allowed to make it up.****

Requests for taking the make-up exam must be **submitted in writing VIA EMAIL and include SCANNED documentation** explaining and substantiating why your inability to take the exam during the designated class session was legitimate. An approval to allow you to take a make-up exam **will be based solely upon the professor's evaluation of your request and any supporting documentation.**

B) Quiz: You will have ONE quiz in class on September 15. This quiz will be graded and is worth 4% of your grade in this course. The purpose of this quiz is to prepare you for Exam 1. **You MUST bring a GREEN OR BROWN SCANTRON AND A #2 PENCIL** to the classroom for this quiz. **Note: If you are absent on the day of this quiz, the same policy for missed exams will apply.**

C) Writing Assignment: You will have ONE required writing assignment that is worth a total of 4% of your grade. The writing assignment will take place during **FINALS WEEK (THURSDAY, Dec. 15 for this section)** and requires you to write about issues that address **your awareness of societal and/or civic issues, critical thinking, and communication** skills. Detailed instructions on how to complete the writing assignment will be provided to the class. **NOTE: Since the Writing Assignment is due during Finals Week, if you do not submit it by the deadline, you will receive 0% and only be allowed to make it up in *the most extraordinary of circumstances*, with a legitimate reason AND supporting documentation (same policy for making up missed exams).**

Note: Personal computer and internet connection problems do not excuse the requirement to complete all course work in a timely and satisfactory manner. Each student needs to have a backup method to deal with these inevitable problems. These methods might include the availability of a backup PC at home or work, the temporary use of a computer at a friend's home, the local library, office service companies, Starbucks, a TAMUC campus open computer lab, etc.
