## **Course Description**

This class prepares the student for writing their exhibition statements and proposals proposal, through a thorough examination of writing, research practices, and exposure to important theoretical issues and significant texts in the field. This course examines how approaches to understanding and interpreting art have evolved over time. A variety of research methods such as iconography, formalism, social history, biography, as well as feminist, Marxist, and post-modern theories will be explored. This course will examine the historical context in which these options emerged as well as the implications of adopting a particular approach.

## **Student Learning Outcomes**

- 1. To recognize, assess, and employ art historical methodology
- 2. To learn to read critically to determine an author's approach or biases
- 3. To learn the basic tenets of scholarly writing, citing sources, and thesis paper organization and development
- 4. To perform specialized research using the methods discussed in class, resulting in an exhibition statement/proposal

#### **Course Instruction Methods and Student Expectations:**

This course will require both reading material located in the D2L classroom and WKly reading assignments from the course textbooks. WKly attendance with active participation is required via Zoom. Assessments include an exam and a research project culminating in an exhibition thesis and class presentation.

## **Active Class Participation:**

Students are expected to attend class WKly via Zoom, having done the assigned reading and prepared to critically evaluate the theoretical implications of the readings, the contribution of the readings to the theme under discussion, and the relationship between a given WK's readings and previous WKs' themes. The success of each WK's discussion depends on the preparation of all the class participants. Posting questions to the D2L discussion board prior to class meetings constitutes part of participation grade.

Attendance: You may be absent from class twice. There is no distinction between excused and unexcused absences. On your third absence you will receive an "F" in the class. Two tardies of 20 minutes or more equals an absence. A tardy of 60 minutes equals an absence.

- Exhibition Statement Final Draft: 50 points, due Dec. 13
