# **Course Description**

This course introduce and consolidate database systems and information management. It is designed to develop knowledge and skills in data modeling, design, and the representation of information in relational database systems. Structured Query Language and advanced features of relational database systems will be utilized to develop database applications. In addition, this course will include topics on the physical characteristics of databases, techniques for improving access to information, and improving performance and reliability with relational database systems.

- Comprehend then implement web database programming fundamentals by developing an application program interface (API) to access and maintain a relational database;
- Learn and implement the principles and concepts of information integrity, security and confidentiality;
- Apply ethical computing concepts and practices to database design and implementation.
